Supreme Court Rule 201(p) deals with the inadvertent disclosure of material subject to a claim of privilege or work product protection. Illinois Rule of Evidence 502 deals with limitations on waivers of the attorney-client privilege and work product protection. These rules became effective on January 1, 2013.

Amicus Committee

This President's Message would be incomplete without an acknowledgement of the efforts of our Amicus Committee. This year alone saw the committee active in *Simpkins v.
