
Survey Opened January 6, 2025 closed January 31,2025

72 Districts responded (There are 169 districts that participate in NSLP, so this # represents 43% of NSLP participating districts)

Districts were asked to report their debt as of December 2024 (debt commences with the start of the school year, there is no carry over from prior years)

Debt accumulated during approximately 16 weeks of school

Geographically, districts in every county and 8 of 9 DRG responded





Key Takeaways

- In a 2025 survey of CT school nutrition directors, 43% of districts reported an increase in school meal debt in fall of 2024. This is 17 percentage points higher than the national average debt (source: SNA)
- The average debt per district is \$11,981 this fall with an anticipated average debt of \$18,600 by the end of the school year. This is x% higher than the national average.
- The total reported school meal debt from Sept-Dec is **over \$850,000** with an **estimated end of school year debt of 1.34 million dollars.**
- Districts who have 1 or more schools eligible but not all schools participating in the Community
 Eligibility Provision where students are able to eat at no-cost, reported more total student debt
 than non-CEP participating districts
