Society for the Environment calls for clear action in celebration of World Environment Day

As part of our celebration of World Environment Day the Society for the Environment announces three initiatives calling for collective action.

Firstly, the Society for the Environment is calling on UK Government leaders to commit to the inclusion of sustainability as an ethical standard for everyone in a public role. Secondly, the Society is writing to the European Commissioner calling for closer alignment of the management of forests, water catchments and basins. Finally, the Society is launching a new campaign highlighting the cultural important of environmental change noting 'we cannot be green by legislation alone'.

Sustainability as an Ethical Standard for Public Roles

Currently all public office holders are required to agree to the seven 'Nolan' principles as their ethical standard. This includes selflessness, integrity, objectivity, accountability, openness, honesty and leadership. Legislation in Wales has already added sustainability as an additional principle and the Society is calling for the rest of the UK to do the same.

Everybody has the right to a healthy, clean and safe environment. However, the world has limited resources and we must consider economic, social and environmental sustainability both now and in the future. We recognise that our community must always have sustainability central in their decisions. The UK Government has stated its wishes to allow economic growth to continue, but more sustainably, to ensure that the costs of growth do not result in excessive environmental deterioration or social justice.

So that we have the best chance for a sustainable future, we urge all the Governments of the UK to adopt a principle of sustainability for all those appointments to which the Nolan Principles apply, so that office holders always include sustainability in the decisions and actions they take. This is vital to the well-being of future generations.

We have written today to the Governments of the United Kingdom and to the Chair of the House of Commons Committee on Public Services.

Closer Alignment of the Management of Forests, Water Catchments and Basins

The Society has written to the European Commissioner for the Environment, Marine Affairs and Fisheries, Karmenu Vella, extolling the virtues of closer alignment of the management of forests, water catchments and basins. This will ensure greater resilience in flood risk management but also will enhance landscapes and increase the opportunities for biodiversity.
