LIFETIME MEMBERSHIP

Definition:

2. Invitations/Discounted Registration fees to ASBA meetings and events.
3. A forum for alumni to stay in touch with one another.

Qualifications:

1. Retired and no longer active in the industry
2. Past Industry Merit award winners
3. Past Life Members
4. Served as ASBA Chairman
5. Served as Division Presidents
6. Served 2 full terms on the Board of Directors
7. 20 years of membership in good standing
8. Other than the above, any 2 of the following:
 - a. 10 years of membership in good standing
 - b. Speaker at 2 Technical Meetings
 - c. Author 2 position papers
 - d. Design 2 technical drawings
 - e. Task Force Chair (2 terms)
 - f. Committee Chair (2 terms)
 - g. Certified Builder

Restrictions:

1. Not eligible to serve in a leadership position or vote as a member

Application statement:

The application for Lifetime Membership shall contain the following statement: "I am retired and no longer active in the industry. If my employment status changes, I understand that my Lifetime Membership can be revoked."
