INSTRUCTIONS and INFORMATION

- Mail your completed form and letters of recommendation to TAAO, 2028 East Ben White Blvd., #305, Austin, TX 78741.
- Complete applications received by the deadline will be forwarded to the Scholarship Committee for review and consideration. You may be contacted by the committee for additional information during the process.
- Two \$750 scholarships will be awarded to current CTAs or those pursuing a CTA. Recipients will be announced during the Annual TAAO & ICTA Conference; you do not need to be present to receive an award.
- Scholarship awards may be used to pay for TAAO courses, workshops and annual conference registration fees, and for associated hotel expenses. Awards may not be used for this year’s annual conference or for any events prior to this year’s conference.
- Scholarship awards are non-transferrable and must be used within five years of the date awarded.
- The recipient must be a current TAAO/ICTA member at the state level and if not a life member, an employee of a governmental entity, or a company under contract to a government entity and actively working in the field of appraising, assessing and/or in the collection of taxes in order to redeem scholarship funds at the time of the request.

APPLICANTS MUST MEET THE FOLLOWING QUALIFICATIONS

- Be a current active or affiliate member of the statewide Texas Association of Assessing Officers.
- Provide three letters of recommendation, one of which must be from applicant’s current supervisor.
- Have not received an ICTA scholarship award within the past two years.
- Cannot qualify for both the Katherine Anthony “Toni” Trumbull Scholarship and the Walter Stoneham Scholarship in the same year.
