## CODE OF PRACTICE

1. Member Companies/Individuals (Members) of the MIA have committed themselves to maintain a high standard of quality and service to purchasers of motorsport products and services.
2. In achieving membership of the Association they have had to meet the required standards of experience, proficiency and commercial competence. As Members they are bound by the regulations of this Code of Practice, which are intended to maintain a high and improving standard of performance.
3. Purchasers of goods and services from Members who feel that the Member in question has fallen below that standard, may submit details to the Association. Members who are shown to persist in practices which the MIA find unacceptable, or fail to maintain proper standards of quality and performance, will be liable to expulsion from membership.
4. The MIA maintains a Mediation Panel, which can assist in the settlement of disputes between its Members and their clients. This Mediation Service is normally restricted to the technical, rather than the contractual, aspect of the dispute. Any costs are met equally by both parties to the dispute.
5. Members may elect to submit details of disputes, in which they are involved, to this Panel and by so doing commit themselves to being bound by its findings.
6. A dissatisfied purchaser, who cannot resolve a dispute with a Member, may submit details to the Panel, which will invite the Member also to submit details. The Panel will consider all circumstances, make recommendations, and take action as appropriate to resolve the dispute.
7. Enquiries and submissions should be directed in the first instance to the:

8. To qualify for membership of the MIA, Members must meet the membership criteria and agree to the Code of Practice.
