With the increase of venture capital companies and private equity firms investing in healthcare entities small and large, there are notable impacts to the delivery of care. At the outset of these relationships, careful attention must be paid to the terms of any agreement and how the new ownership structure impacts service, reinsurance, insurance policies, rates and the corporate structure. Litigation risks and handling of cases by defense counsel are also impacted with potential bigger pockets to handle losses and working with financial entities not familiar with the day-to-day operations of a healthcare company. Travis has testified before various committees of the U.S. Congress, European Union, German Parliament, and the French Senate. His achievements in the USADA's mission of preserving the integrity of sport and competition are widespread, but he is best known publicly for his leadership in investigating the Lance Armstrong pro-cycling team doping conspiracy and was featured in numerous TV and media stories on the Armstrong prosecution, including an incredible segment on the show "60 Minutes". Travis has been recognized by Sports Illustrated as one of the 50 Most Powerful People in Sports, and TIME's 100 Most Influential People in the World in 2013.
