



Overview

The Ontario Ministry of Citizenship, Immigration and International Trade invites you to be part of the Ontario Trade Mission to MRO Europe 2016 in Amsterdam, The Netherlands.

Six established Ontario companies will have the opportunity to exhibit in the Ontario Pavilion located in the centre of the MRO hall and accessible via the main aisles leading into the hall. Participants will also receive several value-added services including an up-to-date database of potential clients and promotion at the trade show. Now, in its 18th year of operation, MRO Europe 2016 is expected to draw over 5,000 trade visitors from 80 countries, host over 400 exhibitors and attract international trade press representing all facets of the MRO industry.

Who should attend?

This Mission and show will be of interest to experienced exporters with innovative products or services for the aerospace maintenance, repair and overhaul industry.
