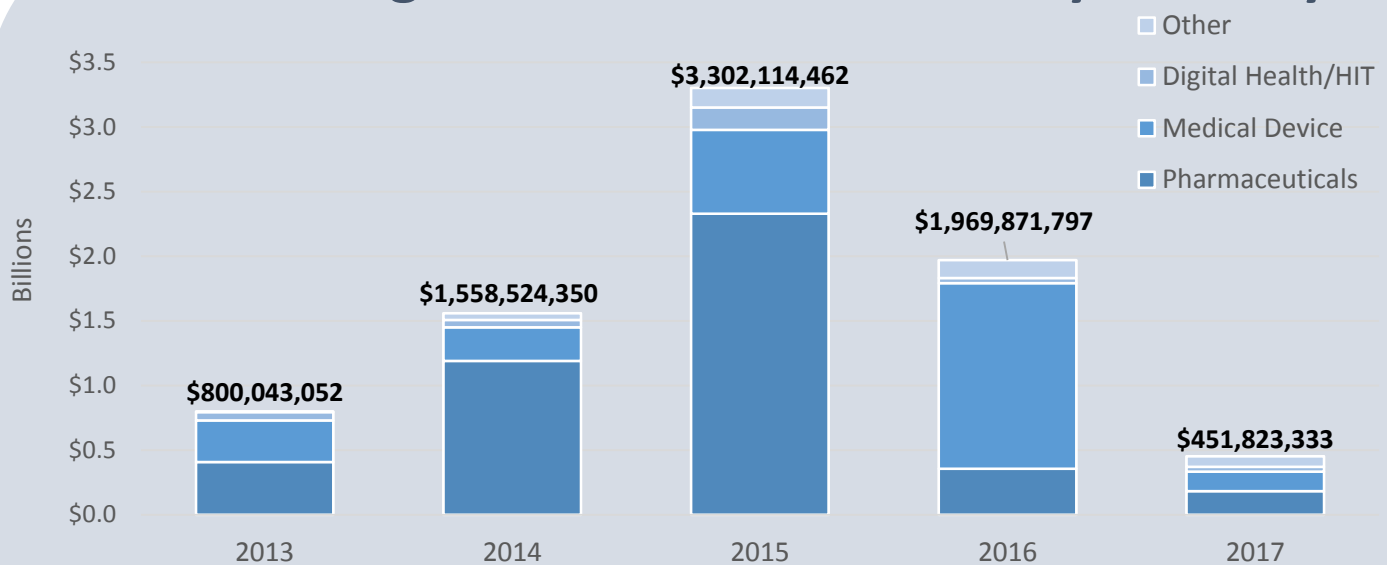


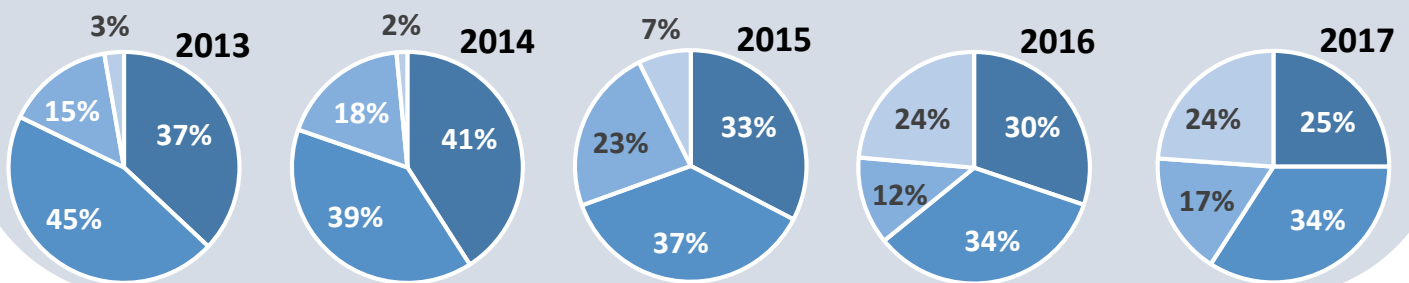

Highlights

- *SiDx* raised \$1.59M of seed funding from undisclosed investors, putting the pre-money valuation at \$6.5 million.
- *Just Biotherapeutics* raised \$59M of Series B venture funding in a deal led by Temasek. Hangzhou Economic and Technological Development Area (HEDA), Lilly Asia Ventures (LAV), ARCH Venture Partners, Taikang, Bank of China (BOC) and Bank of Hangzhou also participated in the round. The company intends to put the funds towards additional advancement of biologics development and clinical trials.
