OVERVIEW

Patient information breaches present a major threat to chiropractors everywhere. The time has passed when clinics could do a little on their HIPAA program each week and expect to have a passable program by year's end. Clinics must have a full program in place immediately that includes ongoing upkeep and maintenance to guard against cyber-attacks and other forms of patient information breaches.

Be certain that you and your staff understand the required written security policies that must be in place. Learn the definition of "Willful Neglect," how doctors receive this designation, and how you can avoid it. Understand the very real threat of Ransom Ware attacks, which, because of our massive amounts of information in patient's health files, has made its way to mainstream television.

Take away concrete steps to establish a HIPAA program and develop an ongoing program to keep everything current from now on.
