**ABOUT THE SCHOLARSHIP**

The Wisconsin Chiropractic Association, in conjunction with the Luedtke-Storm-Mackey Chiropractic Clinic (LSM), is proud to announce the Dr. Kenneth Luedtke Scholarship.

Dr. Luedtke was a giant in our profession whose dedication through political advocacy advanced chiropractic both in Wisconsin and nationally. His tireless efforts resulted in several pro-chiropractic laws being enacted during his lifetime. He served as both President of the Wisconsin Chiropractic Association and the American Chiropractic Association.

To honor his legacy, the WCA and LSM Chiropractic established a \$2,000 scholarship to be awarded to a student who demonstrates both academic achievement and chiropractic advocacy in the community.

The scholarship winner will be announced at the WCA Fall Convention. The winner will receive an overnight stay at the Kalahari Resort in Wisconsin Dells and will be recognized at the evening awards ceremony on Saturday, September 26, 2020.

**REQUIREMENTS / CONSIDERATIONS**

- The individual has matriculated into a chiropractic college in the Doctor of Chiropractic program.
- The student is in the sixth trimester or higher.
- The applicant is a student-member of the Wisconsin Chiropractic Association.
- The student is either from Wisconsin or intends to practice in Wisconsin upon graduation.
- The student has maintained a cumulative grade point average of at least 3.1.
- The student has demonstrated a commitment to the chiropractic profession through participation in extracurricular activities that advance a positive image of the profession in the community.
  - An example would be volunteering at a free health clinic to assist those doctors providing chiropractic services.
- The student has demonstrated a commitment to the chiropractic profession by becoming involved in activities or with organizations that advocate for the chiropractic profession.
  - An example would be joining the student ACA organization at their school, serving as an officer or assisting in a local, state or national petition or drive intended to advance rights for patients to have equal access to chiropractic services and/or to have those services reimbursed on an equal basis with medical services.
  - Other examples would be volunteering to assist the campaign of a legislator who has demonstrated support of the chiropractic profession in his or her legislative actions. Another example would be meeting with a legislator to advocate for the profession and patients.
