'Tactical' Privacy for the Front Lines

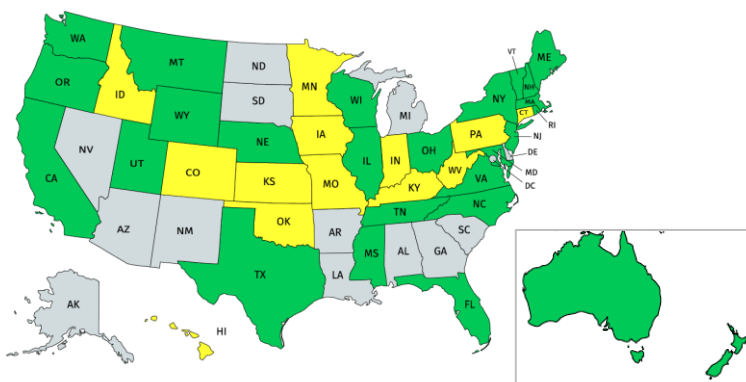

Over the past 2 years there have been more than 100 student data privacy legislative efforts crafted in more than 35 states with even more activities going on internationally. While most federal, state and territory education



agencies voice that they want to support their school's privacy issues, most realize these needs are best addressed locally by practitioners who are most vested in keeping student data secure and private.

In 2015 the non-profit **Student Data Privacy Consortium (SDPC)** was established to address these "tactical" and "on the ground" needs. Formed after a year of research, outreach surveys, and one-on-one conversations, the SDPC is now made up of thousands of schools, regional and state/territory education agencies and marketplace providers identifying common privacy issues and developing solutions that can be put in place at all levels of the education data continuum. Much of the work of the Community is done in formed (green) or forming (yellow) state "Alliances" - check out the SDPC's membership exponential growth and work in 2019!

Addressing "on the Ground" Pain Points

The Consortium is designed to address the day-to-day, real-world multi-faceted issues that schools, states, territories and vendors face when protecting learner information. SDPC's vision is to develop common activities, artifacts, templates, tools and effective practices that can be leveraged through a unique collaborative of end users and marketplace providers working together. Together this community has identified 3 initial projects to help deliver on the promise of data privacy for all learners!

Privacy Contract Framework - *The Privacy Contract Framework project is focused on the development of a framework for identifying solutions that have on-the-ground and real-world impact on student data privacy enabling schools, districts, state and vendors find resources, adapt them to their unique context and implement needed protections.*

Digital Governance Tool - *The Digital Tools Governance Tool is a comprehensive framework for aligning a school's policy landscape, strategic programming, tactical processes, and accountability mechanisms to support the system's*

vision of how its digital tool ecosystem will advance while minimizing its risks of data privacy and security incidents.

Global Education Privacy Standard (GEPS) - The "GEPS" leverages the collaborative strength of the SDPC to develop a freely available privacy technical standard that would help identify the "right data to the right application" in a standard transport manner. <https://privacy.A4L.org/privacy-connect>
