In this role, Desgranges leads a team of directors, supervising attorneys and other staff in working to develop and advance innovative civil rights impact litigation and policy reform initiatives, build and maintain coalitions with other community organizations and leaders, engage in public education and media advocacy, and collaborate with defenders to address the systemic legal issues affecting Legal Aid's public defense clients. Desgranges is also a member of the Board of Directors of the New York City Bar Association.

Before joining Legal Aid, Desgranges was a senior staff attorney at the New York Civil Liberties Union, where he focused on statewide civil rights and civil liberties impact litigation. Desgranges previously worked as an associate at Goodwin Procter LLP, where he litigated commercial matters and a wide range of pro bono matters, including a death penalty appeal. He also previously worked as a public defender at The Bronx Defenders, where he represented indigent clients at all stages of criminal proceedings, including trying cases to verdict.

Desgranges graduated cum laude from Boston University in 2006, and he graduated from New York University School of Law in 2009.

Marika Dias is the Director of the Urban Justice Center's Safety Net Project (SNP), which provides tenant legal services, public benefits and homeless advocacy, and also organizes with welfare recipients and homeless New Yorkers. Marika is a public interest attorney who has worked in civil legal services since 2001, with a focus on providing legal services that support community organizing efforts and grassroots organizing groups. Prior to her role at SNP, Marika was the Director of the Tenant Rights Coalition at Legal Services NYC and before that, she was the Managing Attorney at Make the Road New York. Marika is a member of the Steering Committee of the Right to Counsel NYC Coalition, works on the Right To The City Alliance's national legal committee, and is a movement lawyering trainer which includes work with partners such as Movement Law Lab, the Law and Political Economy Project, The Action Lab, and the Shriver Center on Poverty Law.

Kevin Jason, Esq.

Deputy Director of Strategic Initiatives, NAACP Legal Defense and Educational Fund, Inc.

Kevin E. Jason is Deputy Director of Strategic Initiatives at the NAACP Legal Defense and Educational Fund, Inc. He leads and supervises racial justice litigation and other forms of advocacy in various areas of law. Generally, his docket focuses on police practices and educational equity matters that combine impact litigation with policymaking, community organizing, and strategic communications.

Before joining LDF, Kevin worked at the ACLU of New York (New York Civil Liberties Union). Immediately after law school, Kevin served as a law clerk to the Hon. Steven M. Gold of the United States District Court for the Eastern District of New York (retired) and to the Hon. Andrew L. Carter, Jr. of the U.S. District Court for the Southern District of New York.

Kevin received his J.D. from Stanford Law School. He also earned an M.A. in Public Policy from Stanford University and a B.A. in Economics and Political Science from Columbia University.

Jenny Lam practices in the area of employee benefits at Cohen, Weiss and Simon LLP since August 2022.

Prior to joining the firm, she practiced traditional labor law and employee benefits at Archer, Byington, Glennon & Levine LLP. Ms. Lam was a Peggy Browning Fellow at Workers Defense League, where she represented workers challenging denials of their unemployment benefits. She was also a law clerk at Levy Ratner, P.C.

Ms. Lam graduated from Benjamin N. Cardozo School of Law in 2020. She was the Senior Articles Editor of the Cardozo Journal of Equal Rights and Social Justice (formerly the Journal of Law and Gender), where she also published her Note, Mending Violence Against Women Workers in the Bangladesh Garment Industry: An Anti-capitalist Perspective on Fabrications of "Improving" Labor Conditions. Ms. Lam represented unemployment benefits claimants and

provided hotline assistance to individuals regarding their benefits at the onset of the COVID-19 pandemic at the Unemployment Action Center. She advocated on behalf of low-income elderly and disabled individuals and immigrants at federal, state, and administrative proceedings with the Bet Tzedek Civil Litigation Clinic. She also served as the two-term president of the Suspension Representation Project and volunteered with the Asian American Bar Association Pro Bono Clinic and the People's Parity Project.

Ms. Lam graduated magna cum laude from Stony Brook University in 2016 in three years with a bachelor's degree in philosophy. Shortly after completing her undergraduate studies, she was selected as a 2016 Fellow with Philosophy as an Inclusive Summer Key summer institute with the theme of social justice. Prior to law school, Ms. Lam was a retail worker.

Executive Director, Asian American Legal Defense and Education Fund

Bethany Li is the executive director of the Asian American Legal Defense and Education Fund (AALDEF), bringing over 20 years of experience in community/movement lawyering working with Asian American communities and other communities of color. She has led litigation and policy efforts on issues such as deportation defense, immigration, workers' rights, housing and displacement, language access, and hate violence.

Bethany has represented Southeast Asian immigrants facing deportation; sued Florida over its anti-Chinese alien land law; won millions in back wages for low-wage workers; represented a multiracial coalition to defend and promote racial equity in Boston Public Schools; and represented multiple coalitions resisting displacement, including a successful effort in Philadelphia's Chinatown to defeat the proposed 76ers arena.

Bethany began her career at AALDEF as an Equal Justice Works Fellow, returning as Legal Director in 2022 and becoming executive director in 2024. She previously led the Asian Outreach Unit at Greater Boston Legal Services, Massachusetts' largest legal program serving Asian American communities, and taught in the Veterans Legal Services Clinic at Yale Law School.

Bethany earned her J.D. from Georgetown University Law Center.
