ASIAN AMERICAN BAR ASSOCIATION OF NEW YORK PUBLISHES KNOW YOUR RIGHTS BROCHURE TO COMBAT HATE CRIMES AND BIAS INCIDENTS AGAINST ASIAN AMERICANS AND PACIFIC ISLANDERS IN NEW YORK

NEW YORK -- May 19, 2021. In light of the current surge in anti-Asian hate and violence, the Asian American Bar Association of New York (AABANY) is proud to announce the publication of a Know-Your-Rights brochure created to inform members of the Asian American Pacific Islander (AAPI) community in New York about their legal rights when experiencing a bias incident or hate crime. The brochures are available online in English and Chinese.

The brochure explains what a hate crime is under the New York State hate crime statute and differentiates between a hate crime and a bias incident. The brochure also provides guidance to individuals on what actions to take during and after an incident, including making a sound or video recording, noting the perpetrator's physical appearance and clothing, and collecting bystander witness contact information. The brochure outlines procedures for pursuing action through the criminal justice system or civil lawsuits and provides information on reporting incidents.

Additional translations of the brochure into other Asian languages are expected to be released shortly. AABANY encourages the AAPI community and allies to share and distribute the brochures to anyone who may benefit from its contents.

"AABANY has long fought against anti-Asian racism, discrimination and xenophobia, even before the current national crisis," states AABANY President Terrence Shen. "During this time of elevated hate and violence against members of the AAPI community, AABANY has continued to serve as a resource to those affected, offering interpretation and translation services, legal information and referral services, and other forms of assistance. This brochure represents our latest effort to provide AAPI community members in New York with another tool to respond to anti-Asian incidents or attacks."
