## ASIAN AMERICAN BAR ASSOCIATION OF NEW YORK CONGRATULATES JUSTICE JEFFREY K. OING (RETIRED) ON HIS JOINING JAMS, LARGEST PROVIDER OF ALTERNATIVE DISPUTE RESOLUTION SERVICES WORLDWIDE

NEW YORK – January 9, 2025 – The Asian American Bar Association of New York (AABANY) congratulates Hon. Jeffrey K. Oing (Ret.) on his joining JAMS, the largest private provider of alternative dispute resolution (ADR) services worldwide. Justice Oing will now bring his wealth of experience as an arbitrator, mediator, and neutral evaluator to JAMS, where he will manage cases across multiple areas of law, including business, intellectual property, and employment law.
