Asian American Bar Association of New York Congratulates its Trailblazing Member Alice Young on Being Honored with Womankind's 2025 Lifetime Achievement Award

The Asian American Bar Association of New York (AABANY) is proud to celebrate Alice Young, a longstanding member of AABANY, on receiving the Lifetime Achievement Award from Womankind at their 2025 Communities Rising Gala on October 29, 2025.

At its 2025 gala, Womankind will honor Alice Young for her sustained impact and leadership in law, advocacy and community building. The Lifetime Achievement Award recognizes individuals whose work has advanced equity, inclusion, and opportunity across generations. The gala will be held at 6:30 PM, October 29, 2025 at Tribeca 360, 10 Debrosses Street, New York City.

Alice Young is a pioneering lawyer and consultant whose four-decade career has been marked by trailblazing achievements.

- She was among the first women graduates of Yale College and one of the earliest Asian American women to graduate from Harvard Law School.
- On Wall Street and in private practice, she served as partner and led Asia practices at major law firms (including Arnold & Porter Kaye Scholer and Milbank Tweed), advising multinational corporations and structuring cross-border transactions.
- She founded Alice Young Advisory LLC and has served as independent board director for AXIS International Capital Holdings Ltd. and Mizuho Trust & Banking Co. (USA).
- Beyond her professional work, Alice has long been an advocate for diversity, women's advancement, and equitable inclusion in corporate and civic spheres.

"Alice Young's lifelong dedication to justice, equity, and mentorship exemplifies the spirit of this award.
