MISSION STATEMENT

The Asian American Bar Association of New York was formed in 1989 as a not-for-profit corporation to represent the interests of New York Asian-American attorneys, judges, law professors, legal professionals, legal assistants, paralegals and law students. The mission of AABANY is to improve the study and practice of law, and the fair administration of justice for all by ensuring the meaningful participation of Asian Americans in the legal profession.

HISTORY

In 1988, the New York State Judicial Commission on Minorities, headed by noted African American attorney Franklin Hall Williams, examined the treatment of minority litigants and court employees. Following hearings in New York City on June 29th and 30th of that year, Rockwell Chin approached Commissioner Serene K. Nakano to discuss the need for an organization for Asian American attorneys. While Chinese and Korean American lawyer associations existed, there had never been an association of Asian American lawyers in New York.

Further impetus came when the National Asian American Bar Association (later called NAPABA) Planning Committee invited various attorneys in New York City to Chicago in October 1988. A core group, including Rockwell Chin, Glenn Ikeda, Yat T. Man, Steve Min and Serene K. Nakano, worked to found a formal association of Asian American lawyers: drafting organizational documents, reaching out to New York and nationwide bar groups, and contacting other Asian American attorneys.

Announcing AABANY's incorporation on October 20, 1989, the group invited attorneys to an inaugural reception at New York University Law School on November 9, 1989. Among the speakers were Judge Dorothy Chin Brandt, Judge Randall Eng, Judge Peter Tom, past president of the American Immigration Law Association Benjamin Gim, Professor Sharon Hom, AALDEF Program Director Stanley Mark, and former NYPD Deputy Commissioner Hugh Mo. All of the speakers emphasized the unfulfilled need for AABANY. The reception was a resounding success, with over 180 attorneys and law students attending. Before the meeting concluded, over 60 people had joined AABANY.

AABANY, operating under an interim board during its first year, hosted further receptions, including evening social events, as well as a meeting at Brooklyn Law School at which Hoyt Zia, then the first President of NAPABA, spoke. Newly formed committees also sprang into action. The Issues Committee, co-chaired by Rockwell Chin and Marilyn Go, began research on redistricting, assisted lobbying for bias crimes legislation and spoke out against bias incidents. The Business Law Committee, co-chaired by Ken Chin and Marilyn Go, established a speaker series of prominent Asian American attorneys. The Events Committee hosted a fall picnic. Prompted by concerns raised by law students at the picnic, Chin Fong and James Minamoto established a student mentor program, presenting a job skills workshop to help law students hone interviewing skills.

On January 12, 1991, AABANY held its first annual meeting, electing Serene Nakano, Doris Ling-Cohan, Steve Min, Glenn Ikeda and Marilyn Go as officers and Rockwell Chin, Sylvia Fung Chin, Merlin Liu, Stanley Mark, Qazi Moid and Judge Peter Tom as directors.

Now one of the most prominent and active minority bar associations in New York, AABANY has well over 1,100 members, including practicing attorneys in the private and public sectors, in-house lawyers, judges, professors and law students.

MEMBERSHIP SECRETARY'S REPORT TREASURER'S REPORT

Irene Tan, Membership Secretary

The Membership Committee, chaired by the Membership Secretary, develops recommendations for programs and services that will meet the needs of the current membership and encourage new members to join AABANY.

In 2014, the Committee kicked off the year with the successful completion of its "March to 1,000" Membership Campaign. This significant milestone was recognized at the Annual Dinner where AABANY celebrated 25 years of progress and growth and the achievement of exceeding 1,000 paying members. On April 10, 2014, the Committee hosted an event to celebrate its growing membership and to welcome new members to the organization.

Presently, AABANY has more than 1,100 active, dues-paying members. Of the total membership, 24.3 percent identified themselves as lawyers in the private sector and 12.3 percent as lawyers in the public sector. Law students comprise 20.1 percent of the total membership. Compared to 2013, AABANY's membership grew by approximately 18.2 percent.

The Committee dedicated its efforts this year to developing a formal strategic plan that identifies several new initiatives to increase membership and streamline the administrative process of maintaining AABANY's large membership roster. The Committee also conducted a benchmarking review of other peer organizations and presented bylaws recommendations pertaining to membership categories and annual fees to the Board. These were approved and will go into effect as of February 13, 2015.

The Committee continues to co-sponsor the "Get-to-Know AABANY" networking series that focuses on increasing membership by promoting selected committees every year. In 2014, the Committee hosted two Get-to-Know AABANY events, which featured the Student Outreach Committee, Young Lawyers Committee, and Mentorship Program in July at the Rubin Museum and the Intellectual Property, Pro Bono & Community Service, and Student Outreach Committees in August at Barn Joo. The Committee plans to host a third event in late March.

In addition, the Committee focused on providing targeted workshops and programs for its membership. This year, the Committee co-sponsored the "Get On Track" Series with the Young Lawyers and Career Placement Committees, which consisted of two well-attended panels that respectively discussed the partnership track and alternative careers for lawyers. The Committee looks forward to growing the organization's membership base and to improving the membership experience for both current and prospective members.

Jane Chuang, Treasurer

In 2014, with the help of our sponsors, members and other supporters, we increased our membership roll, added new committees and offered a diverse slate of programming to empower and unite our community. These efforts have enabled us to maintain our reserves and expand our budget, as reflected in the state of our treasury.

For the 2014 fiscal year, the Board approved a general operational budget of approximately \$570,000.00. With this budget, AABANY hired an additional staff member (our new Program Associate Simone Nguyen), expanded the number of its committees, focused on enhancing its signature events and funded numerous CLEs and other events.

As of February 4, 2015, our investment account balance is \$383,113.38 and our operating account balance is \$177,312.49. Our Investment Manager Kai Chong Cheng of Merrill Lynch's Private Wealth Management Group has invested AABANY's funds in accordance with the conservative approach set forth in AABANY's Investment Policy. For 2014, AABANY's total performance return (including cash and investments) was 0.30%.

We thank you for your help and involvement this year and hope you will continue to join us in our efforts to chart new frontiers next year.

YEAR IN REVIEW

True to our theme of Empowering Progress and Unity, 2014 marked yet another year of tremendous growth and energetic activity for AABANY. Thanks to the generous efforts of our friends and members, we were able to engage the AABANY community and the community at large, collaborating with bar associations and community partners to present our premier flagship events, educational panels and CLE programs, to perform community outreach, and to provide social and networking opportunities.

This year, we were pleased to announce the formation of three new Committees: the LGBT Committee, the Military and Veterans Affairs Committee, and the Tax Committee. The Litigation Committee formed and appointed a chair for a new ADR Sub-Committee. More details about these committees appear in the Committee Reports. Our AABANY administrative family also grew with the addition of a full-time Program Associate.

AABANY granted a posthumous membership to Hong Yen Chang, first Chinese immigrant admitted to any bar in the United States, in support of UC Davis' APALSA's efforts to posthumously admit him to the California State Bar, where he was denied admission in 1887 due to his race and lack of United States citizenship.

At the 2014 Annual Meeting, AABANY revised its bylaws to change the fiscal year, so our fiscal year 2014 ends on March 31, 2015. Upcoming noteworthy events in February and March 2015 include several events and panels run by our various committees, such as the Tax Committee's 2015 Kickoff Event and Women's Committee 'Kicking Glass' Video Project. We look forward to our Annual Meeting, which takes place on February 12, 2015, where we will be holding our elections as well as voting on changes to the AABANY bylaws. On February 25, 2015, we will be celebrating our 26th Anniversary Dinner at Cipriani Wall Street, at which we will be introducing our theme for next year: Charting New Frontiers.

Below are some highlights from 2014 that illustrate how AABANY empowered progress and unity in the APA legal community and beyond.

DON H. LIU SCHOLARSHIP FUND

Among notable accomplishments in 2014 was the tremendous growth of the Don H. Liu Scholarship Fund, announced at last year's Annual Dinner. The Don H. Liu Scholarship Program focuses on developing a pipeline for Asian Pacific American lawyers, and seeks to identify and cultivate future leaders. Each Don H. Liu Scholar will receive:

- A financial scholarship of \$15,000;
- Access to numerous AABANY programs;
- Opportunities for summer employment and internships; and
- Mentoring, guidance and support by the Scholarship Committee and others throughout his/her law school and legal careers.

The purpose of the Don H. Liu Scholarship Program is to:

- Identify, cultivate and inspire future Asian American leaders of the legal profession;
- Bring together national and local leaders of the Asian American legal community (the "Scholarship Committee") to select, mentor, guide and support Scholarship recipients throughout their law school and legal careers; and
- Provide financial support during law school to Scholarship recipients.

Scholarships are awarded to first-year law students.

SPECIAL EVENTS

FEBRUARY 26, 2014 — On its 25^{th} *Anniversary Annual Dinner*, AABANY celebrated past and present accomplishments while looking forward to the next quarter-century. See sidebar.

APRIL 10, 2014 — In celebration of reaching our goal of 1,000 paying members by the time of AABANY's Annual Dinner, the Membership Committee headed by

Irene Tan hosted a 1,000 Members Happy Hour at People Kitchen & Lounge, attended by new members and veterans alike. AABANY raffled Yankee tickets, symphony tickets, Beats headphones, and much more to new members.

OCTOBER 18, 2014 — As part of the recently opened "Chinese American Inclusion/Exclusion" exhibit at the New York Historical Society, AABANY performed a shortened version of its highly engaging "22 Lewd Chinese Women" Trial Reenactment, led again by Hon. Denny Chin. In yet another performance of this popular trial reenactment since the 2013 NAPABA Convention, we examined important issues of immigration, federalism, human trafficking, and civil rights in

the case of Chy Lung v. Freeman via performance, narration, discussion, and photography. Following the shortened version of the script, Hon. Denny Chin, Kathy Hirata Chin, Vince Chang, and David Weinberg led a discussion about the historical impact of anti-Asian discrimination and the unknown fate of the 22 Chinese women, exposing the many ironies of the case, including the fact that the women had indeed won their freedom in court and yet were still probably forced into lives of prostitution. The audience did not consist primarily of lawyers and the program was recorded for later broadcast on New York Historical Society's website and podcast, showing the widespread impact of the case not just in the legal community, but the community at large.

in the United States Supreme Court decision in Schuette v. Coalition to Defend Affirmative Action, reminding us why race matters and matters still.

May 21, 2014 — Led by Judge Denny Chin, AABA-NY collaborated for the first time with the New York City Bar Association to present a trial re-enactment of "22 Lewd Chinese Women: Chy Lung v. Freeman," the 1876 case in which a state official determined 22 women on a ship carrying some 600 Chinese passengers to be 'lewd,' i.e. prostitutes. The women were not allowed to disembark unless a bond of \$500 was paid on each. Legal proceedings ensued, including a four-day trial and appeals

reaching the United States Supreme Court, raising issues of immigration, sex trafficking, federalism, and human and civil rights. The reenactment featured a dramatic performance of the trial proceedings, accompanied by narration, illustrated with historic photographs, The re-enactment was videotaped by Planet Depos, one of the event's sponsors, which also used real-time transcription that appeared on projected screens. New York City Bar made the video available on its website as a CLE program.

MARCH 8, 2014 — At the Third Annual Columbia Asian Pacific American Law Students Association, "On the Shoulders of Giants: New Horizons for Asian Americans in Law and Politics," AABANY Immediate Past President Mike Huang, President Clara Ohr, and Board Member Karen Lim, joined Helen Wan (author, *The Partner Track*) and Vivia Chen (blogger, The Careerist) on a panel entitled "Navigating the Career Ladder: Professional Development Strategies for Asian American Attorneys." The event focused on Immigration Reform, Minority Identity, and Professional Development. The keynote speaker was former New York City Comptroller John Liu.

MARCH 25, 2014 AABANY co-sponsored the New York State Bar Association's "Achieving Diversity in the ADR Field: Overcoming Old Challenges and Seeking New Opportunities." A panel of renowned ADR providers, scholars, and administrators discussed their practices for recruiting and selecting neutrals, the efforts they have undertaken to diversify their rosters of neutrals, and their efforts to further expose the users of their ADR services to racially and ethnically diverse panels of arbitrators and mediators. Another panel, moderated by AABANY member Theo Cheng, and comprising distinguished ADR neutrals, provided perspectives on how to navigate a successful career as a neutral; recommended specific networking, marketing, and promotional activities; discussed how best to leverage diversity issues; and provided practical tips for increasing the opportunities for being selected as a neutral. Finally, there was a discussion about strategies for addressing cross-cultural issues in dispute resolution, followed by a networking reception.

MARCH 30, 2014 — Along with the Coalition for Asian American Children & Families, AABANY co-sponsored "An Endangered Species – The NYC Department of Education's Specialized High Schools Admissions Test: Perspectives from the Asian American Community," organized by AABANY members Chris Kwok and Nelson Mar. At the Flushing Library, members of the Asian American and Specialized High Schools (SHS) community, including education activists, SHS alum, parents, and students, met to address the NAACP complaint leveled against the single test criteria for admission to the NYC high-performing Specialized High Schools, backed by the Asian American Legal Defense and Education Fund. This discussion brought together the community by giving voice to all sides of the argument and illuminating the depth of the issue in New York public schools.

APRIL 1, 2014 — In his "Uncovering Talent: The Case of Asian Americans," part of the 14th Annual Korematsu Lecture Series, presented by the NYU Asian-Pacific American Law Students Association, Chief Justice Earl Warren Professor of Constitutional Law Kenji Yoshino spoke about the phenomenon of 'covering,' discussed at length in his first book, Covering: The Hidden Assault on Our Civil Rights. The Korematsu Lecture Series, since 2000, has recognized Asian Americans whose work challenges legal boundaries and serves as an inspiration to all people of color. AABANY has been featured as part of this lecture series and continues to support all partners involved in making the education and access to Asian American history possible.

APRIL 29, 2014 — The Asian American Judges Association of New York held a panel on "How to Become a State Court Judge, from the APA Perspective." Hon. Doris Ling Cohan served as moderator. On the panel were the Hon. Lillian Wan, Hon. Gilbert Hong and Hon. John Lansden. All the judges present spoke about their individual paths to the judiciary and the challenges encountered along the way. Judge Ling Cohan posed questions to the panelists about the process of becoming a judge and how those who aspire to become judges can navigate their careers to reach their goal.

JUNE 5, 2014 — At "Why Choose International Arbitration?" our co-hosted CLE and reception with Alston Bird, AABANY member Lou Russo moderated panelists Michelena Hallie (Viacom, Inc.), Suzanne Ulicny (ICC International Court of Arbitration), John D. Roesser (Alston & Bird LLP), and AABANY member Charles Yoon (Yoon & Kim LLP). The panel emphasized the importance of keeping in mind possible conflicts in the midst of celebrating a closed deal. "Why Choose International Arbitration?" discussed international courts, choosing international arbitration as an alternative to time-consuming litigation, and effective arbitration clauses.

JULY 23, 2014 — The Korean American League for Civic Action held a Law Career Panel, as part of their Public Interest Panel Series, at Kobre & Kim, LLP, followed by a short networking session. Former Recording Secretary of AABANY Karen Kim moderated the panel consisting of the Honorable Gilbert C. Hong (New York Criminal Court, Kings County), Jane C. Kim (Deputy Bureau Chief, Crime Strategies Unit at the King's County DA's Office), AABANY Labor and Employment Law Committee Co-Chair Christopher Kwok (United States Equal Employment Opportunity

Commission), AABANY In-House Counsel Committee Co-Chair Austin So (Associate General Counsel & Corporate Secretary, Heraeus), Jihee Suh (Assistant Attorney General, NYS Office of Attorney General), and Jimmy Yan (Chief Deputy General Counsel, Office of NYC Comptroller Scott M. Stringer). Panelists expressed the need to expand one's network, pursue risks, and challenge the convention that there is only one set method of success in the profession. The panelists shared that true success happens when a successful attorney helps the advancement of others in reaching success in their careers. Judy Kim, former AABANY Membership Secretary and NAPABA Northeast Regional Governor, organized this panel.

DECEMBER 15, 2014 — AABANY took part in the Historical Society of New York Courts' Stephen R. Kaye Memorial Program entitled "Asian Americans and the Law: New York Pioneers in the Judiciary," with an audience of over 300 attendees. The program was preceded by a reception at which most of the currently sitting APA judges in New York were in attendance. In addition to the APA judges, leaders from AABANY, KALAGNY, SABANY and FALANY were present at the reception. Judge Denny Chin and Kathy Hirata Chin presented a history of Asian Americans and the law, touching on four seminal cases that helped shape not only the Asian American experience but also the legal landscape of America. The cases were subjects of trial re-enactments that Judge Chin and Kathy Chin spearheaded for AABANY. They discussed the following cases: Chy Lung v. Freeman ("22 Lewd Chinese Women"), Heart Mountain, Tokyo Rose and Vincent Chin. The presentation was accompanied by a slideshow of historic images, many of them reflecting the racism and anti-Asian sentiment that was prevalent at the time. After the presentation, Judge Chin led a conversation with three APA pioneers on the New York bench: Hon, Peter Tom (Justice, 1st Dept. Appellate Division), Hon. Randall Eng (Presiding Justice, 2d Dept. Appellate Division), and Hon. Dorothy Chin-Brandt (Justice, New York Supreme Court, Queens Co.). The lively and freewheeling discussion chronicled the trailblazing careers of each judge, showing the great strides each made for Asian Americans in the law and the judiciary, providing strong inspiration for those who would follow the paths they cut for future generations.

COMMUNITY EDUCATION AND OUTREACH

MARCH 1, 2014 — In conjunction with the MinKwon Center and Open Hands Legal Services, AABANY members provided free legal assistance in immigration matters in Manhattan Chinatown. A total of 26 walk-in and by-appointment members of the community were able to find and seek support from the free legal clinic.

MAY 1, 2014 — AABANY was pleased and privileged to be part of a special screening of "Documented: A Film by an Undocumented American" at the Asia Society. Jose Antonio Vargas, the Pulitzer Prize winning journalist who revealed in a 2011 essay in the New York Times Magazine that he was undocumented, created a moving, powerful, poignant and thought-provoking film following him in his public and personal struggle with the aftermath of his coming out as an undocumented American.

MAY 3, 2014 — Community groups in Chinatown gathered at Hok Shan Association on Mott Street for a Press Conference for Hon. Doris Ling-Cohan's Appointment to the New York State Appellate Term. Judge Ling-Cohan is the first judge of APA descent in that court. Chinese press and media were out in full force.

MAY 17, 2014 — The Joint Minority Bar Judicial Internship Program 2014 Orientation Program took place at the New York City office of Littler Mendelson, P.C. This year, JMB JIP helped place 27 law students in judicial internships with various federal and state judges/justices in New York. JMB JIP Co-Director William H. Ng, Labor and Employment Law Committee Co-Chair and Associate at Littler Mendelson, provided an overview of the New York State and Federal court systems. JMB JIP Founder and Co-Director Linda S. Lin, AABANY Past President and Board Director, then Senior Counsel. Liberty International Underwriters, taught a legal writing and research course entitled "Tackling Assignments Successfully." The JMB JIP interns also participated in an interactive writing assignment that required them to review, analyze and edit a legal brief. The orientation program concluded with a career panel with current and former law clerks, including AABANY President-Elect William Wang. JMB JIP's 2014 partners include the Asian American Bar Association of New York, Asian American Law Fund of New York. MAY 31, 2014 —

Attorneys can receive 1.5 CLE credits, including .5 ethics credit, and are required to work a 3-hour shift.

According to AABANY's bylaws, the duties of the Audit Committee shall be to:

- vii. review with such auditors any material questions or problems with respect to accounting records, procedures or operations of the Association that have not been resolved to their satisfaction after having been brought to the attention of management and recommend to the Board what actions should be taken with respect thereto;
- viii. review and recommend to the Board investments for the Association's assets:
- ix. regularly review the existing investments of the Association's assets and recommend to the Board whether such investments should be terminated and recommend to the Board possible new investments for such assets;
- x. report to the Membership at the Annual Meeting the status of all investments of the Associations; and
- xi. perform such other duties as may be assigned by the Board.

The panelists stressed the importance of not only doing near-perfect work but also developing the soft skills that make clients, bosses, and coworkers trust you. Panelists even explored "the secret room where all the decisions are made" — that is to say they acknowledged that when only 16.5% of partners are female and only 5.4%are minority, it is imperative to have allies and advocates that will make the case for why you in particular stand out among associates. overwhelmingly positive feedback and has become one of AABANY's signature events connecting a broad community of lawyers and vendors.

At the AABANY Annual Fall Conference, the Committee once again worked with the In-House Counsel Committee to organize the second annual Law Firm/In-House Pitch Sessions, which provided law firm participants an opportunity to engage in live pitch sessions to in-house counsel. This year, the Committee and the In-House Counsel Committee introduced a number of innovations to the matching process in an effort to more closely match law firms with in-house counsel based on the practice areas of the firms and the needs of the in-house counsel. The Pitch Sessions provided law firm participants with opportunities for developing business and fostering relationships to develop future business while providing in-house counsel with the opportunity to network with new law firms.

Inc.), consisting of Marianne Chow (Counsel at the Hearst Corporation and Co-Chair of the Women's Committee), Ellen Ching (senior M&A associate at Paul, Weiss, Rifkind, Wharton & Garrison LLP). Charlotte

Kim, Bobby Liu and Lawrence Wee, discussed the importance of negotiation skills and the actual and perceived ability to "control a room" in advancing to partnership at a law firm or to senior positions in in-house legal groups. The panel members also discussed hurdles that APA attorneys often face in a negotiation setting (whether due to cultural differences, stereotypes or other factors and shared how they have overcome such hurdles and found their own unique "voice" as successful APA attorneys. The panel also provided participants with concrete advice on how, as APA attorneys, they can set the tone and more effectively control a room in a negotiation and get clients what they need. The panel members then participated in a mock negotiation to demonstrate their negotiating styles, with commentary with respect to the how's and why's of the negotiating strategies and techniques used, focusing on effective lawyering to get clients what they need. The session was very well-attended and was met with positive feedback.

At the Fall Conference, the Committee also collaborated with the Commercial Bankruptcy and Restructuring Committee to host a panel and discussion, titled "Debt Restructuring Master Class," dealing with tips and tactics in debt restructurings.

The panel for this discussion consisted of Hugh Hill (General Counsel of Southport Lane Management, LLC), David Hong (Associate General Counsel of King Street Capital Management, L.P.), Vincent Roldan (Partner at Ballon Stoll Bader & Nadler, P.C. and Co-Chair of the Commercial Bankruptcy and Restructuring Committee) and Lawrence Wee. The panelists provided participants with an overview of the issues that arise in debt restructurings, practical advice for practitioners and a discussion of "dirty tricks" and traps for the unwary in debt restructurings. This session was also well-attended and received positive feedback.

In November 2014, Committee Co-Chair Dwight Yoo chaired and moderated a panel discussion at the National Asian Pacific American Bar Association (NAPABA) Conference, which was held in Scottsdale, Arizona. Dwight and Larry were happy to help carry the AABANY flag at the Conference, along with the other members of the sizable AABANY contingent.

The Committee looks forward to presenting and sponsoring additional programs in 2015-2016 that it hopes will be relevant and helpful to APA corporate lawyers and law students interested in corporate law practice.

The Finance Committee, consisting of Jane Chuang, Bobby Liu, Yang Chen, and Clara Ohr, reviewed the third-party discretionary spending budget allocation for the 2014-2015 Fiscal Year.

GOVERNMENT SERVICE & PUBLIC INTEREST COMMITTEE

During 2014-15, co-chairs Katrina Goyco, YuJin Hong, and Karen Kithan Yau continued to bring public interest subjects to Government Service & Public Interest (GSPI) Committee programming, expanded pro bono opportunities to AABANY members, and provided much-needed pro bono representation to low-income Asian Americans and others. It also sought to develop an active membership and a participatory committee culture, and promote an environment in which lawyers in the government service and public interest sector can connect.

During 2014-15, GSPI Committee launched an important initiative, the U-Visa Pro Bono Project, in collaboration with Legal Services NYC, for immigrant victims of domestic violence. Launched in June 2014, spearheaded by the GSPI Committee, with the support of AABANY's Pro Bono & Community Service (PBCS) Committee, the initiative matched pre-screened survivors of domestic violence with trained pro bono lawyers and law students on the U-Visa application, as well as how to work with victims of abuse. Dozens of AABANY members provided pro bono services. Ten survivors of domestic violence (and counting) got legal representation that they otherwise would not have. For her leadership, co-chair Katrina Goyco was honored as one of Legal Services NYC's Top 30 Pro Bono Lawyers of 2014. This exciting project continues into 2015, with potential to branch out to other types of immigration matters and other practice areas in the future.

On Wednesday, August 20th, the GSPI Committee joined forces with the PBCS Committee for a wine and cheese reception and information session on AABANY's exciting public interest projects. On Wednesday, August 20th at the 308at156 Art Gallery at Lee Anav Chung White & Kim LLP, the GSPI Committee joined forces with the PBCS Committee for a wine and cheese reception and information session on AABANY's exciting public interest projects. Over 60 attorneys and law students attended the event. James Cho spearheaded the organization of this event.

For AABANY's Fall Conference on September 20th, GSPI Committee organized a discussion panel on "The Civil Rights Movement: APAs Moving Forward," which pondered the impact of the civil rights movement on the Asian Pacific American (APA) community in the US and the role of APAs in the civil rights movement. The program provided an overview of the historical experience of Asian Pacific Americans in the realm of civil rights, examined changes in Asian American communities over the past generation, the disparities among those communities, as well as broken barriers and uphill challenges still being addressed today. It also discussed the impact of White House Diversity Initiative in shattering glass ceilings and the connections between contemporary issues of civil, social, and economic rights and the Civil Rights movement. Co-chair Karen Yau moderated the panel. Over 20 AABANY members participated. Katrina Goyco, Chris Kwok, and Karen Yau chaired this program.

On September 28, 2014, the community presentation, "Helping Undocumented Youth Who Qualify for Deferred Action for Childhood Arrivals (DACA)" provided community members in Sunset Park information on how to apply for a groundbreaking two-year moratorium on deportation and the opportunity to secure a work permit for eligible immigrant youth under the federal Deferred Action for Childhood Arrivals program. It was co-sponsored by the Asian American Legal Defense & Education Fund, its undocumented pan-Asian American youth group, Revolutionizing Asian American Immigrant Stories on the East Coast (RAISE), New York Immigration Coalition, as well as the Office of Council Member Carlos Menchaca. Members of the Immigration and Nationality

Law Committee provided pro bono legal advice to several community members. Katrina Goyco chaired this program.

On November 18, 2014, GSPI Committee, the Racial Justice Project of the Impact Center for the Public Interest and Asian Pacific American Law Students Association (APALSA) at New York Law School presented the CLE program, "Shattering the Model Minority Myth: Asian Pacific Americans Facing Poverty in NYC." Moderated by co-chair (and program organizer) Karen Yau, the panel of speakers included representatives from NYC Human Resources Administration, Housing Court, Mayor's Office for Immigrant Affairs, and MinKwon Center for Community Action. Andrew Scherer, Policy Director of the Impact

Center and Joseph Chung, President of the New York Law School's APALSA, welcomed attendees. During the program, panelists shared their recent experience with Asian Americans facing poverty, challenged the 'model minority' myth, and discussed the burgeoning APA population of NYC and their unique needs. More than 40 participants attended the event. The program offered 1.5 CLE credits.

In late March 2015, working with many other Asian American groups, the GSPI Committee will co-host a discussion and social event at the Chinese Inclusion/Exclusion exhibit at the New York Historical Society. Rocky Chin and Toni Kong are organizing this event.

During 2014-15, the GSPI Committee continued to get together during membership meetings, which drew the attendance of a dedicated group of old and new GSPI members, fostering the development of new leadership.

Exciting programs are already being developed for 2015-16. In early April 2015, the GSPI Committee will co-sponsor with Korean American League for Civic Action (KALCA) a discussion forum on the current debate on changing admission criteria for entrance into the NYC Specialized High Schools.

The Immigration and Nationality Law Committee promotes and advances the interests of APA attorneys who practice immigration and nationality law. Our goal is to provide support and professional development for immigration practitioners, many of whom are either in solo or small firm practice, by providing CLE seminars, networking opportunities, and other events.

In response to the devastation caused by Typhoon Haiyan in the previous year, Co-Chair Rio Guerrero made various efforts throughout the year with the American Immigration Lawyers Association to advocate for Temporary Protected Status for Philippine nationals in the United States.

The Intellectual Property Committee was started in 2011 with the goals of: (1) providing practical skills training, support and opportunities for practicing and aspiring intellectual property lawyers in the New York area; (2) providing resources for artists, authors, and inventors in the Asian American community; and (3) serving as a forum to explore U.S.-Asia intellectual property issues. The IP Committee received the inaugural Outstanding Committee of the Year award for 2011.

MAY 28, 2014 — In view of past popularity of its IP Skills Workshop series, the IP Committee kicked off its year with a skills CLE program. Treasurer Jane Chuang (Partner at Lee Anav Chung White & Kim LLP) and Committee member Charles Chen (Assistant General Counsel at HICKIES Inc.) led the "Copyright Registration: Part V of the IP Skills Workshop Series" CLE at Bingham McCutchen (courtesy of Committee member Thomas Hou), organized by our Intellectual Property Committee. The principal function of the Issues Committee is to advise AABANY's leadership on emerging developments in policy, the legal profession, AAPI issues, or other matters on which the organization may contemplate taking a public position. The issues considered by the Committee tend to be of broad interest to AABANY's members across practice areas or else have a broad impact on APA communities. The Committee's role is in part responsive –providing advice on developments in issues of standing interest– and in part proactive – identifying and bringing to the leadership's attention pertinent issues not currently addressed by existing committees.

The Committee also represents AABANY at meetings, workshops, forums, and other events that address issues in which AABANY has an interest but which may fall outside the traditional scope of the subject matter of the other committees. In addition, the Committee participates in advocacy campaigns to which AABANY has made an organizational commitment. Finally, the Committee serves as a vehicle through which AABANY may undertake special initiatives on targeted issues, including research projects on issues of broad potential impact on AABANY's members.



On March 30, 2014, Chris Kwok organized a panel at the Flushing Library in Queens on the Specialized High Schools Admissions Test, a topic that the Issues Committee continues to follow.

Issues on which the Committee advised AABANY:

NYC Specialized High School Admissions Test
 ("SHSAT") — In the fall of 2014, the Issues
 Committee produced an extensive memorandum
 briefing the debate on NYC's Specialized High
 School Admissions Test and recommending
 a position for AABANY to take on this issue.
 The Issues Committee Chair collaborated with
 interested AABANY members and chairs of
 the Government Service and Public Interest
 Committee to set forth a proposed internal
 system through which AABANY members
 can provide input on AABANY positions. A
 subcommittee was formed to organize a town hall
 addressing the debate on the SHSAT.

- Akai Gurley Whether AABANY should issue a statement on NYC Police Officer Peter Liang's shooting of Akai Gurley.
- Whole Foods Employee Whether AABANY should issue a statement on a Whole Foods employee's calling a Chinese customer "Ching Chong." The Issues Committee assisted in connecting the customer with a local community board to raise concerns about personnel training with Whole Foods.
- Uniform Bar Exam Whether AABANY should comment on New York's proposed transition to the Uniform Bar Exam.

Events at which the Committee represented AABANY:

1. Sponsored the Voting Rights CLE panel held at the Annual Fall Conference.

In 2015, the Committee plans to do the following:

- The Issues Committee is helping to organize a panel discussion on the SHSAT issue. Chris Kwok is leading the organizing effort along with KALCA. The event is scheduled to take place on April 3, 2015. at CUNY AAARI.
- Work to establish a more transparent and member-involved process through which AABANY's positions on issues are crafted and approved.

JUDICIARY COMMITTEE

The Judiciary Committee leads AABANY's efforts to increase the number of qualified Asian Pacific American ("APA") attorneys in the federal, state, and local judiciary and to advocate for the interests of APA judges, including increasing judicial pay and preserving judicial independence.

The Judiciary Committee's efforts fall into four main categories:

- It screens candidates for the judiciary to determine whether AABANY should formally support those candidates. The methodology for AABANY's screening process is posted on the AABANY website.
- It recruits and prepares candidates seeking their first judicial office, as well as sitting judges seeking higher judicial office.
- 3. It lobbies for and supports candidates for the judiciary whom AABANY has endorsed.
- It engages in advocacy (speeches, legislative testimony, public forums, amicus briefs, and editorials) on issues related to judicial independence and judicial selection.
- The Judiciary Committee seeks internally to increase awareness of issues relating to the judiciary among AABANY's members.

The past year was another productive year for the Judiciary Committee:

Throughout 2014, the Judiciary Committee continued to vet, support, and advise candidates for various judicial positions. Most prominently, we vetted two candidates for U.S. District Judge positions and supported them with letters to Senators Schumer and Gillibrand. We also vetted two candidates for Magistrate Judge positions and supported them with letters as well.

On the state side, we vetted and endorsed two candidates for the New York Court of Appeals. Both candidates made it to the short list submitted to the Governor's office for separate vacancies. The Judiciary Committee reached out to various APA community groups and organizations to join AABANY in support of an APA candidate's appointment. We issued a letter to the Governor's office with 17 signatures representing 17 such organizations.

AABANY's Judiciary Committee also supported the application of a sitting APA judge for the New York Court of Claims and another

sitting judge for the position of Administrative Judge. Finally, we vetted and supported four candidates' applications for the New York City Criminal, Family, and Civil courts by the Mayor's office. We also met with Desiree Kim, Executive Director of the Mayor's Advisory Committee on the Judiciary to discuss and support these candidates.

On July 7, 2014, AABANY's Judiciary Committee held an organizational meeting at Dechert LLP where we discussed the committee's short and long-term goals, as well as effective ways to achieve them. Our next committee meeting will be held on February 11, 2015.

During AABANY's Fall Conference on September 20, 2014, the Judiciary Committee hosted a Judicial Forum. The morning was dedicated to the federal bench and began with a panel discussion entitled "Federal Judgeship - Why you should consider this path and what it takes to get there." The panelists included Hon. Margo Brodie, U.S. District Judge for the Eastern District of New York; Hon. Pamela Chen, U.S. District Judge for the Eastern District of New York; Hon. Sarah Netburn, U.S. Magistrate Judge for the Southern District of New York; and Michael Park, Dechert LLP as moderator. The afternoon was dedicated to the state bench and began with a panel entitled "New York State Judge/Justice – why you should consider this path

and what it takes to get there." This panel featured Hon. Randall T. Eng, Presiding Justice, N.Y. Supreme Court Appellate Division, Second Department; Hon. Jeffery K. Oing, Justice, Supreme Court of the State of N.Y. Commercial Division; Hon. James M. McGuire, Dechert LLP, former Associate Justice, N.Y. Supreme Court Appellate Division, First Department; Hon. LABOR & EMPLOYMENT LAW COMMITTEE

COMMITTEE CHAIRS

In 2014, AABANY's Labor & Employment Law Committee ("L&E Committee") completed its inaugural year, which was filled with many great educational programs and social and networking events.

The L&E Committee looks to promote the professional development of lawyers and human resources professionals practicing or engaging in Labor & Employment law through CLE programs, career panels, and networking events. The L&E Committee actively seeks to connect the Asian American community with the expertise of the lawyers and human resources professionals in the L&E committee, and to promote the education and discussion of work place issues affecting employees, employers and their families.

On January 22, 2014, the L&E Committee held its kick-off event, "Employment Law Update 2014" at the New York offices of Seyfarth Shaw. More than 20 employment law practitioners attended the program, including representatives from the National Labor Relations Board (NLRB), U.S. Equal Employment Opportunity Commission (EEOC) and New York State Department of Labor. Program speakers included Hema Chatlani (Littler Mendelson), Jane Chung (Gladstein, Reif & Meginniss LLP), Michael Yim (FordHarrison) and Joane Wong (National Labor Relations Board). The panelists discussed New York City's recently enacted paid sick leave law and pregnant workers fairness act; restaurant delivery workers improperly denied tips ordered via food websites; hot trends in non-compete laws; and recent NLRB decisions and policies regarding use of social media in the workplace. The program was moderated by L&E Co-Chair William H. Ng (Littler Mendelson, P.C.).

On April 15, 2014, the L&E Committee together with the Membership Committee sponsored a Happy Hour at Pranna Bar and Lounge. More than 30 attorneys, law students and friends of AABANY showed up for a wonderful evening of networking and socializing.

On June 4, 2014, L&E Co-Chair Christopher M. Kwok spoke at the New York County Lawyers' Association's (NYCLA) Alternative Dispute Resolution (ADR) Committee at JAMS NY to discuss his experience at the EEOC. Each NYCLA ADR Committee meeting features an ADR expert: Chris spoke to an intimate audience of 15-20 NYCLA members. The EEOC is responsible for enforcing federal laws that make it illegal to discriminate against a job applicant or an employee because of the person's race, color, religion, sex (including pregnancy), national origin, age, disability or genetic information. Chris walked the NYCLA ADR Committee through the process of investigation, cause, and conciliation and how to go forward with a case using the right amount of engagement and emotional investment to effectively resolve and settle. More generally, Chris also spoke about body language, preparation, and looking for facts that cannot be disputed — useful tools in any conflict.

On June 12, 2014, AABANY and EEOC, hosted Lu Jun, a distinguished human rights lawyer from China. Lu Jun is the Chief Coordinator of Beijing Yirenping

Center ("Center for Promotion of Equality and Mercy" or "Yirenping"), a non-profit organization dedicated to promoting social justice and public well being in China. Yirenping offers education on communicable disease prevention and control, provides community outreach and assistance for patients, and works to eliminate discrimination. Lu Jun spoke about his cases of impact litigation against employment discrimination due to many factors: gender, age, hepatitis B status, appearance, disability, etc. He spoke about the full gamut of prejudice and how

Yirenping chooses cases that will garner public attention in the effort to halt the discriminatory practices.

During the roundtable discussion, lawyers knowledgeable about the NLRB, New York State Attorney General's Office, and the EEOC shared their insights and comparisons to the protection of workers in the United States. The challenges presented to human rights lawyers are multifaceted, as the political and legal landscape within China is

still under development. Without legislation to rely upon in many cases, Yirenping must offer solutions and gain public support in arguing for workers' rights. In addition to attempting impact litigation, Yirenping also advocates for positive change via seminars on discrimination, survey/research to represent the realities of discrimination, lobbying for legislation, anti-discrimination training, legislative proposals, and public social action.

During the 2014 Fall Conference, the L&E Committee organized a program entitled "Tackling Labor & Employment Issues in Professional Sports and Beyond." This program addressed recent labor and employment issues that have affected professional sports teams, players, and those individuals who work in the sports industry. Panelists addressed the relationship between professional sports teams as "employers" and players/operations staff as "employees." Panelists included Alan Chang (New York Yankees), Chul Pak (Wilson Sonsini Goodrich & Rosati), Howard Wexler (Seyfarth Shaw) and David Fish (New York Law School). The program also covered general labor and employment topics that are applicable to individuals and organizations beyond those involved in the sports industry, e.g., bullying in the workplace, allegations of discriminatory remarks and retaliatory actions, use of paternity leave, and class actions involving allegations of minimum wage violations and unpaid overtime.

In 2015, the L&E Committee looks forward to working with other AABANY committees, Asian Pacific American organizations and sister bar associations to organize valuable educational programs and provide opportunities for those interested in labor and employment to network and socialize in order to help the committee grow.

The Committee organizes programs geared toward LGBT attorneys and allies, including our annual networking reception for LGBT Asian American / South Asian Attorneys. The Committee aims to develop and present career and practice development-related programs that cover a variety of practice areas and legal topics. The Committee also seeks to provide a forum for professional and social networking both within and outside of AABANY through unique networking events.

Asian American/South Asian Lawyers Networking Reception

On September 24, 2014 nearly 70 members of the bar "came out" to celebrate the diversity within the LGBT and Asian American and South Asian communities. LGBT and APA lawyers associations and law firms jointly sponsored the event.

Partners and associates at corporate firms, government attorneys, solo practitioners, small firms, and public interest lawyers enjoyed this networking reception which raised money for students to attend the National Queer Asian Pacific Islander Alliance conference in Chicago in August 2014.

Attendees lauded State Supreme Court Justice Doris Ling-Cohan for her acumen in her ruling in *Hernandez v. Robles*, the first case in New York to rule that the prohibition of same-sex marriage was unconstitutional. Her remarks were followed by special video screenings of Public Service Announcements (PSA) of AAPI parents who love their LGBT kids. The Asian Pride Project produced the PSA and NQAPIA is working to have them placed in Asian ethnic television stations next June during Pride Month.

Special thanks go to Cleary Gottlieb Steen & Hamilton LLP for hosting the reception, as well as LeGaL – The LGBT Bar Association of Greater New York, National Asian Pacific American Bar Association, National Queer Asian Pacific Islander Alliance, and South Asian Bar Association of New York.

Immigration Executive Action and LGBT Asian Americans: What's Good, What's Left Out, and Our Next Steps

On Thursday, February 12, 2015, attorneys and advocates explained President Obama's immigration executive actions and their impact on LGBT Asian American / South Asian immigrants. Specific emphasis was placed on visas for professional workers, student visa OPTS, Deferred Action for Childhood Arrivals (DACA) and Deferred Action for Parents of Childhood Arrivals (DAPA). Individual attorneys were on hand to do consultations.

The speakers included:

- Cyrus Mehta, attorney representing corporations and individuals in business and employment immigration, family immigration and asylum.
- Sin Yen Ling, attorney at QLA, the public defender office in Queens focusing on a criminal immigration issues.

MILITARY & VETERANS AFFAIRS COMMITTEE

On May 8, 2014, AABANY President Clara Ohr approved the formation of the Military and Veterans Affairs Committee. Asian Pacific Americans have served in the armed forces as far back as the Civil War, but, according to the US Census, only about 1.3% of the 21.2 million (275,600) United States military veterans are APAs. However, today, APAs are one of the fastest growing demographics in the military and currently make up 3.8% of the 1.3 million active duty forces. The Committee currently consists of eight members, including veterans, current serving military members, and students. We formed this Committee with the hope of addressing issues that are relevant to today's military and veteran population and provide networking opportunities for APA military veterans.

The Committee has three central missions: (1) Networking and Support; (2) Education and Advocacy; and (3) Pro Bono. The Committee will provide a networking and support platform for current AABANY members with a military background, current military members seeking opportunities outside the military, law students thinking of military careers, and AABANY members interested in issues related to military and veteran affairs. Additionally, the Committee will provide insight to AABANY members on legal issues and legislation affecting military personnel, military families, and veterans, such as the Uniformed Services Employment and Reemployment Rights Act, sexual assault and military justice, and the suicide of Private Danny Chen. Finally, the Committee will work with the Pro Bono and Community Service Committee on opportunities to provide pro bono assistance to military members, veterans and their families.

The Committee met for the first time on July 9, 2014 to discuss its strategic goals for the year. The Committee has built connections with other bar associations, including the New York City Bar Military Affairs and Justice Committee and is looking forward to expanding its membership and raising its profile both within AABANY and in New York City with successful professional and social events in 2015.

PRO BONO & COMMUNITY SERVICE COMMITTEE

COMMITTEE CHAIRS

June Lee, Samuel Lui, and Vina Ha

The Pro Bono & Community Service Committee encourages Asian American attorneys to provide assistance to underserved people and communities. The Committee provides opportunities for pro bono work by developing programs targeting issues affecting low-income people. We also aim to promote AABANY's partnerships with community organizations and legal service providers.

In 2014, three new chairpersons for the Committee were appointed: June Lee, Staff Attorney from Queens Legal Services; Samuel Lui, Senior Staff Attorney from Manhattan Legal Services; and Vina Ha, Counsel for Google.

In the summer of 2014, the Committee partnered with the Government Service & Public Interest Committee and Legal Services NYC (LSNYC) to launch a program for assisting low-income Asian Americans. The program was designed to provide pro bono assistance to clients seeking U Nonimmigrant Status. U Nonimmigrant Status is commonly known as 'U-Visas.' U-Visas are available to victims of certain "qualifying crimes" who have suffered substantial physical or mental abuse and have cooperated with law enforcement.

On Wednesday, June 25, AABANY and LSNYC held a ioint CLE training on U-Visas entitled "Immigration Relief for Low-Income Survivors of Domestic Violence." The training, hosted by Kramer Levin Naftalis & Frankel, presented the legal requirements and step-by-step process for filing U-Visas. Volunteers were trained about the many forms of domestic violence and the sensitivity required in representing low-income domestic violence survivors with limited English-speaking abilities. Volunteers who completed the training were placed in teams and assigned clients. Teams were also paired with LSNYC mentors. Many volunteers possessed language skills that matched language needs of clients seeking representation. Through this program, approximately twenty volunteer attorneys and law students have been representing low-income Asian American victims of domestic violence in U-Visa cases.

On August 20, 2014, the Committee co-sponsored a wine and cheese reception and info session with the Government Services and Public Interest Committee. Over 60 people attended the mixer, which took place at an art gallery located at Lee, Anav, Chung, White & Kim LLP. The aim of the event was to create a space for conversations between those interested in the public sector and members who practiced in those areas. A small panel of practitioners in the public sector offered backgrounds on their practice. Overall, from law students to seasoned practitioners, many people enjoyed and participated in the event.

On October 23, LSNYC hosted their Pro Bono Volunteer Reception 2014 at the offices of WilmerHale. Among the "Top 30 Pro Bono Attorneys" named by LSNYC was Government Service & Public Interest Committee Co-Chair Katrina Goyco. The "2014 Pro Bono Honor Roll" included Executive Director Yang Chen and Past President Sylvia Fung Chin (Partner, White & Case). President-Elect Will Wang represented AABANY at the event.

In 2015, the Committee is hoping to create a housing clinic. Volunteers would assist non-English speaking Chinese seniors and people with disabilities sign up for Senior Citizen Rent Increase Exemption (SCRIE) and Disability Rent Increase Exemption (DRIE). In NYC, more than 90,000 eligible people have not taken the advantage of this program as of January 2015.

The Committee hopes that it will continue to receive enthusiastic participation from AABANY members.

PROFESSIONAL DEVELOPMENT COMMITTEE

COMMITTEE CHAIR

The continuing mission of the Professional Development Committee (PDC) is to advance the skills and knowledge of AABANY's members as they advance in their professional careers. We provide opportunities for members to work together through the administration of our continuing legal education programs.

Continuing Legal Education

This year we are proud to have provided a wide variety of free or low-cost Continuing Legal Education (CLE) programs for our members and the New York legal community. All of our programs are organized and presented by volunteers and are sponsored by generous law firms, corporations, and community organizations. We seek to provide these resources free or at low cost without compromise in the quality or educational value of our programs.

Programs were sponsored by AABANY's committees or with one of AABANY's partners, which included the MinKwon Center for Community Action, the Asian American Legal Defense and Education Fund, the New York City Bar, and SABANY, as well as the Asian Pacific American law student associations at Brooklyn and Columbia Law Schools. The role of the PDC is to provide guidance in organizing and documenting the programs according to the requirements of the New York State Continuing Education Board, issuing CLE credits to participants, and making the required periodic reports to the Office of Court Administration.

AABANY Fall Conference

The fifth AABANY Fall Conference was held on September 20, 2014 at the law firm of Morgan, Lewis & Bockius LLP in New York City. Thirteen 1.5-credit programs were presented by AABANY's committees in a wide range of subjects, such as negotiation and deal making, tax law, civil rights and voting, APA real estate development, not-for-profit law, and dealing with outside counsels. In addition, a full-day intensive program in trial advocacy was taught by experienced judges and attorneys.

In total, we offered 72 credits of continuing legal education. This included 11.5 credits of ethics. All of these credits were free for AABANY members except for the AABANY Fall Conference (\$100 for members, which included breakfast, lunch, cocktail hour, and dinner). This represents a great savings over the cost of CLE programs elsewhere.



Hon. Thomas Tang Moot Court Competition

Past President Christopher Chan and Samuel Yee assisted law student teams from the Northeast Region in this year's Hon. Thomas Tang Moot Court competition. This national competition is designed to encourage APA law students to pursue a career in litigation, as well as to give opportunities to experience moot court not available otherwise. Kristin Lee and Lawson Huynh from St. John's University School of Law were national finalists, and also won the national best brief award.

LEGAL REENACTMENTS

Wards Cove Packing Co. v. Atonio

Our legal reenactment team, led by U.S. Circuit Judge Denny Chin, Kathy Chin, and Vincent Chang,

performed "Justice Denied: Wards Cove Packing Co. v. Atonio" to a capacity room on November 8 at the NAPABA National Convention in Scottsdale, Arizona. This presentation dealt with the employment discrimination cases raised by native Alaskan and Filipino cannery workers and heard by the Supreme Court (490 U.S. 642 (1989)), the 1991Civil Rights Act and NAPABA's fight against the amendment that exempted the Wards Cove Packing Co. from the relief that would have been given these workers.

22 Lewd Chinese Women

We brought the acclaimed production of "22 Lewd Chinese Women" on October 18th to the New-York Historical Society in conjunction with their exhibit "Chinese American: Exclusion/Inclusion." "22 Lewd Chinese Women" is based on the Supreme Court case *Chy Lung v. Freeman*, 92 U.S. 75 (1875), a seminal case establishing the supremacy of federal law in the realm of immigration, but serves as an equally telling tale of the discrimination against the Chinese of the time, as well as the exploitation and trafficking of women. The production was inspired by an article on the website Slate, and was subsequently covered by *The Atlantic* magazine and on National Public Radio's "CodeSwitch" segment on Weekend Edition.

Conclusion

In conclusion, we had a very successful year, providing a wide range of professional development opportunities for our members, and we hope to continue our progress next year. We are truly grateful for the many active members, volunteer presenters, and sponsors who have generously contributed to make this possible.

The Women's Committee (the "Committee") strives to foster the advancement of women in the law and to organize programs geared toward the APA female attorney. The Committee aims to develop and present throughout the year career and practice development-related programs that cover a variety of practice areas and legal topics. The Committee also seeks to provide a forum for professional and social networking both within and outside of AABANY through unique networking events.

In furtherance of this mission, during this 2013-14 term, the Committee has worked to develop and implement programs responsive to the needs and interests of our membership as well as that of the AABANY community at large.

We held a variety of innovative networking events in an effort to reach out to as many members as possible and create different kinds of settings in which attendees could connect. On June 26, 2014 we held our Annual Kick-Off Dinner at Congee Village, where members met each other and learned more about the Committee over a family-style dinner. On July 31, 2014, we co-sponsored with the In-House Committee our second annual women's golf clinic, "Tee Off Your Business Network," a women's business development event that offers a one-to-one ratio of inside counsel to outside counsel. On August 14, 2014, we held our firstever perfume-blending event, led by Scenterprise, Inc. Attendees learned about the twelve olfactory families and created a personalized blend to take home. The golf event and perfume event were each subsidized by a corporate sponsor, resulting in revenues to AABANY and a total savings of several thousands of dollars. To help kick off the New Year, on January 28, 2015, we helped organize a Krav Maga Self-Defense Seminar, co-sponsored by the Young Lawyers Committee and In-House Counsel Committee, where attendees learned the basics of Krav Maga, the official self-defense system of the Israeli Defense Forces and the most practical and aggressive form of self-defense.

Happily, all of our events have attracted both members and non-members. In fact, later this spring, we may be holding a Brazilian Jiu Jitsu seminar coorganized by a non-member who attended the Krav Maga seminar and as a result wanted to get more involved in AABANY. Also in the works for this spring is a book reading of *The Ugly Wife* is a Treasure at Home: True Stories of Love and Marriage in Communist China, possibly in conjunction with a local not-forprofit Asian American writers organization.

This past term we also initiated two new member-oriented programs: Member Meet-Ups, to help Committee members

connect with one another in an informal and casual setting; and Member Profiles, in which we interview prominent women members of AABANY. Our first meet-up, held last fall, was a success with over twenty attendees and many new faces who were drawn to this event for its low-key feel. Our first profile interview has been completed and is in the process of being finalized.

In addition to networking events, we organized and presented two CLEs this year, one at the Fall Conference in September, 2014, and another at the NAPABA Convention in Scottsdale, Arizona in November, 2014.

Our Fall Conference CLE, "Controlling a Room: Negotiation Strategies for Corporate APA Attorneys," was co-sponsored with the Corporate Law Committee and In-House Counsel Committee and had the highest number of attendees for that morning panel session. "Controlling a Room" was a mock transactional negotiation and interactive workshop led by a panel of inside and outside counsel of different backgrounds, genders and styles. The aim of this program was to identify the hurdles that APA attorneys face in a negotiation setting, share tips and stories on how some successful APA attorneys have overcome

such hurdles, and provide participants with concrete feedback and advice and how they can find their own voice in order to effectively control a room during a negotiation.

Our NAPABA CLE, "Kicking Glass from the Courtroom to the Boardroom: Two Decades and Counting," was a multi-media panel program that attracted nearly one hundred attendees and garnered many requests to bring the program back to NYC. "Kicking Glass" was a follow-up program to one that was developed in 1995 and addresses the changing experiences and perceptions of APA women attorneys. For "Kicking Glass," we were able to find a sponsor to underwrite the entire cost of production and post-production of a video—a key component of our program—again resulting in a total savings to AABANY of several thousands of dollars, as well as a committee budget surplus of over one thousand dollars. On the heels of the overwhelming interest in and support for "Kicking Glass," we are in the process of planning a full-length screening and panel discussion on March 5. 2015 at White & Case LLP's midtown offices. Plans are also underway for a screening at another national conference as well.

The AABANY Young Lawyers Committee ("YLC") focuses on the concerns of lawyers admitted to practice ten years or less but is open to all lawyers and law students. Activities include networking receptions, panel discussions and CLE courses of interest to newly admitted attorneys.

On Saturday, April 12, AABANY's Young Lawyer Committee teamed up with New York Cares to clean up invasive species in New York's beloved Van Park. Members Vanessa Fang, Beatrice Bong, Jay Min, Gracie Zhou, and fearless leader Gabe Arce-Yee cleared away invasive Oriental Bittersweet, helping to restore the natural ecosystem of native plant species.

The YLC kicked off the year with its kickoff committee meeting on June 19, 2014 at Duane Morris LLP. Approximately twenty members attended, comprised of both young lawyers and law students. We discussed our plans for the rest of the year, including networking events, workshops and social activities.

On July 11, 2014, we held our first "Get to Know AABANY Happy Hour" at the K2 Lounge at the Rubin Museum. The event was co-sponsored by the Student Outreach Committee and Mentorship Program and allowed young lawyers and law students to learn more about the various committees within AABANY, as well as speak with more experienced practitioners.

The event - titled "Getting on the Partnership Track" - was co-sponsored by the Career Placement Committee and the Membership Committee and took place at Dechert LLP. It featured a roundtable discussion by APA partners across law firms and practice areas, and focused on (1) the soft skills that APA associates or associates in general lack in order to be seriously considered for partnership, (2) the political landscape and stereotypes within law firms that work for and against APA associates in particular, and (3) ways to overcome these hurdles and challenges so that APA associates have a better chance to make partner in the post-financial crisis world. MENTORSHIP PROGRAM

The Mentorship Program was initiated in response to a demand for a more formalized program after a long history of AABANY members engaging in informal mentoring relationships. Currently, over 100 mentors and nearly 300 mentees participate in the program.

The mission of the program is to connect mentors with mentees and provide them with the structure and opportunities to support professional growth and development. When matching mentors with mentees, the program focuses on personal interests and hobbies, in addition to practice areas, in order to facilitate long-lasting relationships that are compatible both personally and professionally.

On July 11, 2014, the Mentorship Program, with the Student Outreach and Young Lawyers Committees, held a mid-summer happy hour at the Rubin Museum of Art, as part of the Get-to-Know AABANY series.
