### **Governmental Membership**

This membership has several tiers based upon population. All have an unlimited number of non-voting members and a set number of voting members. This membership type is for government entities, not individuals. The government entity then provides names of employees to be added as voting or non-voting members. The fees are paid annually. We offer certification programs in the following areas:

- Zoning Enforcement Housing and Property Maintenance
- Certified Code Enforcement Officer
- Certified Code Enforcement Administrator
- Master Code Enforcement Professional

These examinations were developed by AACE in conjunction with ICC (International Code Council) and are based on nationally recognized codes. Upon passage, AACE and ICC award certificates and wallet-sized ID cards. Individuals certified by AACE may add the letters CCEO (Certified Code Enforcement Officer) to their credentials.
