THE PRESIDENT'S CORNER

Saludos, saudações, greetings. I would like to begin this first chat at the President's Corner by thanking those of you who voted for me in 2007, thus honoring me with my third opportunity to serve our Association in a formal capacity. I will do my best to live up to your trust.

I would also like to thank those colleagues whose term on the Executive Council has just ended, for their invaluable contribution to our Association, and to offer a warm welcome to the new members, with whom it will be my privilege to work.

Since I joined the AATSP in the early 1970's, our profession has encountered quite a few challenges, but perhaps none as critical as those we face at present. One aspect of today's challenges concerns the complex issues raised in a document of crucial relevance, namely the MLA report entitled "Foreign Languages and Higher Education: New Structures for a Changed World," originally published in the MLA's journal *Profession 2007* and available at http://www.mla.org/flreport. Comments, criticisms, clarifications, and collaborative responses to the report have been released, most recently in *Profession 2008*. Several concerns have been raised, paramount among them the need to reorganize academic programs and departments to replace what the report described as a "two-tiered language-literature structure," a process that would include reconsidering the role of language program directors in department governance. Furthermore, a new department structure must take into account the distinction, both curricular and programmatic, between high-enrollment language departments such as Spanish, struggling departments such as German and French, and departments of less commonly taught languages.

The 2008 MLA convention featured sessions devoted to discussing the report, and judging from comments made by panelists and members of the audience, it is apparent that while there is a wide range of opinions, there is also a shared feeling that change is imperative for the survival of foreign languages as an academic field, intellectually viable and responsive to current needs. Far from being a negative outcome, this divergence of views underscores the report's success in provoking debate about the goals of language departments and the perceived need of change in order to ensure that those goals are fulfilled. Needless to say, although the MLA report focuses on university and college-level matters, the issues it raises have implications for all levels of instruction, including K-12 and community colleges.

Another set of challenges arises from the unique situation of Spanish as an academic discipline closely linked to the position of the Spanish language in the United States. According

to U.S. Census data, the Hispanic population has grown from slightly over 35 million in 2000 to an estimated 45 million in 2008. As regards the language, according to the 2000 U.S. census, slightly over 28 million people declared they speak Spanish at home, which represented an increment of over 10.5 million in relation to the 1999 census. Depending on which figures one chooses, the United States is the fourth or fifth country in number of speakers of Spanish. Although this extraordinary datum does not imply the United States is a Spanish-speaking society —in the sense of one in which the language is used in all communicative contexts — it does mean that, as an academic discipline, Spanish is in a privileged situation in relation to other languages. No language other than English has such presence in everyday life, particularly in media readily accessible via radio, television, or the Web. Not surprisingly, enrollments in Spanish language courses have reached an all-time high throughout the country. Ironically, this surge of interest comes at a time when financial troubles are leading to cancelling classes, postponing much-needed faculty searches, and increasing course enrollments to levels that turn seminars into lecture courses and make it difficult, if not impossible, to use class time for developing meaningful communicative ability. Furthermore, the welcome growing presence of heritage speakers in our departments should also encourage us to reflect on the fact that much research is needed on issues such as language loss and replacement, the methodology of teaching heritage speakers, and the process of reacquisition of a once-native language (Valdés et al., 2006, 2008). Consequently, rather than constituting a reason for euphoria, the fact that so many students sign up for Spanish classes should fill us with a sense of increased responsibility and encourage us to meditate on and debate the role of Spanish in our society. Arguing that Spanish is no longer a foreign language (Alonso 2007), some scholars have proposed that Spanish departments rethink their character and mission, positioning themselves within the scope of American/U.S. studies, not only to reflect Hispanic culture(s) within this country, but also to establish working relationships with Hispanic/Latino communities in their vicinity. These theoretically and pragmatically thought-provoking ideas require serious consideration, with due attention to details such as what would become of Portuguese, which is generally housed (often in the attic, as it were, but that's another story) under the same roof as Spanish. In a hypothetical reconfiguration of Spanish Studies as part of American Studies, would Portuguese be seen as an unrelated foreign language? This might be problematic, considering that Brazil is part of Latin America, and that students in Luso-Brazilian studies often come from Spanish, as double majors, or minors, or under other arrangements. Suitable accommodation would also be needed for faculty who teach and do research in both Spanish and Portuguese.

As members of the profession, we may hold a variety of views about these issues, but we cannot afford to ignore them. Since these challenges affect all of us, it is urgent that we engage in a continuing dialogue on the most effective ways to meet them in order to carry out our mission as teachers and to strive to maintain a position of leadership in our profession. This is a collective project that requires us to act together — *¡todos a una!*

DEADLINE: APRIL 15, 2009

Pursuant to Section 6.7(a) of the AATSP Bylaws, nominations are submitted each year for the office of **Vice President and three seats on the Executive Council**. The election to be held in 2009 will be for Executive Council seats for 2010-2012. The open seats on the Council are for a representative from the following three areas: K-8, 9-12, and College/University.

Nominations may be submitted by either a chapter or by an individual national member. All nominations must be submitted in writing and sent via e-mail. Each chapter may submit no more than two names of candidates for each elective office. These candidates do not need to be members of the nominating chapter. Regular members not holding chapter membership may also submit names for nomination provided that such candidates are sponsored in writing by a written petition that includes the signatures of at least ten (10) members of the Association in good standing. It is imperative that members and chapters submit names of well-qualified candidates at all levels of instruction in order to maintain highly competent leadership in the Association.

Chapters are urged to discuss possible nominations at their chapter meeting well in advance of the deadline for nominations. Chapters should send a letter of nomination of the candidate(s) for the office of Vice President and/or Executive Council along with a complete curriculum vitae (CV) to the Chair of the Nominating Committee (address below). All documents should be formatted in Microsoft Word and sent as an e-mail attachment.

Members are reminded that the Bylaws require the following:

- A Vice President must be elected each year. That person will serve for three years as Vice President / President Elect in year one, President in year two, and Immediate Past President in year three.
- At least one Executive Council member who is a college/university faculty member must be elected annually. College/university candidates must be paired on the ballot in order to ensure the election of one college/university candidate each year.
- At least one Executive Council member who is a secondary teacher (9-12) must be elected annually. 9-12 candidates must be paired on the ballot in order to ensure the election of one 9-12 candidate each year.
- One Executive Council seat will rotate among a representative from a community college, from K-8, and from Portuguese. In 2009, the position is earmarked for a representative from K-8. Candidates for those rotating positions must be paired on the ballot to ensure that a community college, K-8 or Portuguese representative will be elected every three years.

The Nominating Committee consists of the out-going members of the Executive Council plus at least two other members who do not sit on the Council. Scott Shearon was appointed Chair of the Nominating Committee by the Executive Council at its July 2008 meeting.

The Nominating Committee will conduct its work electronically (via e-mail). The Chair of the Nominating Committee will forward all nomination papers to the 2009 Nominating Committee shortly after the deadline. Each Nominating Committee member will then write a brief evaluation of each nominee's qualifications as outlined on the CV and letters of recommendation. These evaluations are then sent to all members of the Committee for their consideration. Each Committee member then lists all the candidates for each position in rank order. Taking into consideration the rich diversity of our membership and a balanced geographic representation, the two nominees with the highest number of points in each of the slots become the candidates. The Chair of the Nominating Committee then sends the names of each of the candidates to the Executive Director of the Association who will prepare the ballot for distribution to the membership.

1. AATSP OUTSTANDING TEACHER OF THE YEAR AWARDS

The AATSP Outstanding Teacher of the Year Awards are given to teachers of Spanish or Portuguese representing the following four categories:

- A. Elementary Level: Grades K-8
- B. Secondary Level 9-12
- C. Two-year college level
- D. College or university level

Teachers who wish to be candidates for these awards must follow the procedures outlined below.

ELIGIBILITY

To be considered, the nominee must meet the following requirements:

- 1. Membership in the national AATSP for at least five consecutive years.
- 2. Provide evidence of teaching Spanish or Portuguese for at least five consecutive years at any level of instruction.

- 3. Your application materials should include:
 - a. A current curriculum vitae (resume).
 - b. No more than five letters of recommendation which may include letters from administrators, colleagues, or other significant references. Letters of recommendation should be written by those who have first-hand knowledge of the candidate's teaching abilities. Letters should provide evidence of outstanding teaching from a variety of sources such as direct classroom observation; students evaluations; teaching portfolios including videos; review of course syllabi and print and on-line teaching materials.
 - c. A personal statement. The candidate should provide evidence of professional excellence in teaching Spanish or Portuguese in a two-or three-page statement which presents the candidate's teaching philosophy and involvement in related activities and professional organizations. In this position statement the candidate may comment on any of the following topics:
 - 1. How are students inspired to want to speak Spanish or Portuguese and to develop proficiency in the other language skills?
 - 2. How are creativity and ingenuity used in planning classroom activities that help to challenge students?
 - 3. What type of activities are used to develop critical thinking and higher order thinking skills?
 - 4. How is a sense of global understanding developed in the students?
 - 5. To what extent has the candidate demonstrated leadership and participation
 - 6. In what way has the candidate shared knowledge or information with colleagues?
- 4. Individuals who have received this award previously are not eligible to receive the award again and should not apply.

NOMINATIONS

- 1. Nominations may be submitted by any AATSP member in good standing, including self-nominations.
- 2. Each nomination must be endorsed by the candidate's local chapter, which is restricted to one nominee per category.
- 3. The letter of nomination or recommendation should include the following information:
 - a. In what capacity the nominator has known the person nominated.
 - b. How the excellence of the nominee has been assessed.
 - c. The rationale for proposing the candidate as a most deserving person for the award.
- 4. All nomination materials must be submitted in electronic format and sent via e-mail.

• The scholarship will be presented at the Awards Luncheon during the Annual Meeting of the AATSP to be held in Albuquerque, New Mexico on Saturday, July 11, 2009. The winner is expected to be in attendance at the luncheon to accept the award.

2. AATSP OUTSTANDING SERVICE AWARD

The AATSP Outstanding Service Award is given to a member in good standing of the Association who has made outstanding service contributions to the Association.

ELIGIBILITY

- Candidates for this award must be a member in good standing of the AATSP.
- Selection criteria include holding leadership positions within the Association and/or one of its chapters, serving as a chair or member of important Association committees, writing for or editing Association publications, and/or representing the Association in a national or international capacity.
- Individuals who have received this award previously are not eligible to receive the award again and should not apply.

NOMINATIONS

- 1. Nominations may be submitted by any AATSP member in good standing, including self-nominations.
- 2. Nomination materials must include the following:
 - a. A current curriculum vitae (resume).
 - b. Evidence to support the following selection criteria:
 - holding leadership positions within the AATSP and/or one of its chapters
 - serving as a chair or member of important AATSP committees
 - writing for or editing AATSP publications,
 - and/or representing the AATSP in a national or international capacity.
- 3. All nomination materials must be submitted in electronic format and sent via e-mail.

NOTES

• The scholarship will be presented at the Awards Luncheon during the Annual Meeting of the AATSP to be held in Albuquerque, New Mexico on Saturday, July 11, 2009. The winner is expected to be in attendance at the luncheon to accept the award.

3. AATSP CHAPTER INCENTIVE AWARD

The AATSP Chapter Incentive Award will be presented to the chapter that demonstrates outstanding chapter activities along with membership participation. A \$500 honorarium for the winning chapter accompanies this award.

ELIGIBILITY

• Chapters that have received this award previously are not eligible to receive the award again for a period of three years and should not apply for consideration until the three-year period has passed.

NOMINATIONS

Nomination materials must include the following:

- 1. Name of chapter, state, list of officers and contact person with mailing address and street address.
- 2. Information from the Chapter Treasurer including the number of chapter members, the number of Executive Board meetings per year and the number of meetings for members each year.
- 3. List of chapter activities completed and/or planned for the year.
- 4. Nomination materials should also include evidence of chapter activities and programs. The following list is provided as a guide. Actual selection criteria may vary according to the types of activities submitted.
 - Evidence of chapter workshop or speaker for teacher's professional growth. Evidence should include a copy of the publicity flyer or program.
 - Evidence of a social gathering for teachers (such as a luncheon, outing to a theater production, museum). Evidence should include a copy of the publicity flyer or program.
 - Evidence that chapter members give sessions or workshops at the AATSP national or regional conferences and/or at other foreign language conferences. Evidence can include copies of conference programs.
 - Evidence that the chapter promotes participation in the National Spanish
 Exam (NSE). Include information on the prizes and/or awards distributed at
 the chapter level. Submit Evidence can include such items as a program from
 an awards ceremony or other documents that demonstrate the types of prizes
 or awards distributed.
 - Evidence that the chapter promotes participation in the Sociedad Honoraria Hispánica (SHH). Include information on the prizes and/or awards distributed at the chapter level. Evidence can include such items as a program from an awards ceremony or publicity documents for students who win travel awards or scholarships.
 - Evidence of a chapter Newsletter; provide a copy.
 - Evidence of a chapter website: provide a URL.

5. All nomination materials must be submitted in electronic format and sent via e-mail.

4. ROBERT G. MEAD, JR. DISTINGUISHED LEADERSHIP AWARD

The Robert G. Mead, Jr. Distinguished Leadership Award is given to an AATSP member in good standing who has shown leadership within in the profession as a whole and who has made scholarly contributions to the profession.

ELIGILIBITY

- Candidates for this award must be a member in good standing of the AATSP.
- Selection criteria include holding leadership positions in the AATSP and foreign language organizations in addition to the AATSP, making scholarly presentations at conferences, writing scholarly articles, books and textbooks dealing with the teaching of Spanish.
- Individuals who have received this award previously are not eligible to receive the award again and should not apply.

NOMINATIONS

- 1. Nominations may be submitted by any AATSP member in good standing, including self-nominations.
- 2. Nomination materials should include the following:
 - a. Current curriculum vitae (resume)
 - b. Evidence to support the following selection criteria
 - leadership in the AATSP
 - leadership positions in other foreign/world language organizations
 - scholarly presentations at conferences

- research and publications including articles, books, and textbooks dealing with the teaching of Spanish
- 3. All nomination materials must be submitted in electronic format and sent via e-mail.

5. MARIA ISABEL ABREU AWARD

The Maria Isabel Abreu Award is given for the best research article on the teaching of Portuguese as a foreign language. A \$500 honorarium accompanies this award.

ELIGIBILITY

- 1. All articles published after 2004 written in Portuguese, Spanish or English, on the subject of teaching Portuguese as a foreign language are eligible for consideration for the award. Special consideration will be given for articles published in the journal *Hispania*.
- 2. All nominated authors must be AATSP members in good standing at the time of publication of their article and nomination for the award.

NOMINATIONS

- 1. Nominations, including self-nominations may be submitted by any member of the AATSP.
- 2. Nominations must include
 - a. A current curriculum vitae (resume)
 - b. A letter of nomination explaining why the article should receive the award as the best research article on the teaching of Portuguese for the time period in question
 - c. Name(s) of the author(s) of the article along with complete contact information for the author(s)
 - d. Complete bibliographic citation for the nominated article along with **one** of the following: (1) information on how to access the article on-line; **OR** (2) a digital version of the article sent as an e-mail attachment.

6. ISE LANGUAGE MATTERS AWARD

ELIGIBILITY

To be considered, the nominee must meet the following requirements:

- 1. Member in good standing of the AATSP for at least three years.
- 2. Three or more years of experience teaching Spanish in a high school (grades 9-12).
- 3. Demonstrated success in increasing student oral proficiency by using creative methods and exemplary motivation techniques.
- 4. Demonstrated use of authentic immersion experiences outside the classroom during which students apply their speaking skills.

NOMINATIONS

- 1. Nominations may be submitted by any AATSP member in good standing, including self-nominations.
- 2. The letter of nomination or recommendation should include the following information.
 - a. In what capacity the nominator has known the person nominated.
 - b. How the excellence of the nominee has been assessed.
 - c. The rationale for proposing the candidate as person deserving this award.
- 3. The candidate must provide the following materials:
 - a. A copy of a recent curriculum vitae or resume which includes complete contact information.
 - b. No more than five letters of recommendation which may include letters from administrators, colleagues, or other significant references. These letters should be submitted directly to AATSP by email to **corporate@aatsp.org** by

- c. Evidence of professional excellence in the use of creative methods and exemplary motivation techniques for increasing student oral proficiency.

2009 Foreign Language Assistance Program (FLAP) Competitions

The Grants.gov portal is experiencing technical issues. FLAP grant applications will be processed electronically using e-Application.

Applications for grants under this competition must be submitted electronically using the Electronic Grant Application System (e-Application) accessible through the Department's e-Grants system. Information on how to submit your application electronically will be included in the application notices published in the *Federal Register*.

The program information listed in this document is based on best estimates at this time. We are providing this document in order to give potential applicants adequate time to prepare applications. Potential applicants should note, however, that the Department may cancel or revise some of the competitions listed in this document. The Department is not bound by any of the estimates in this document. We advise you to read the actual individual application notices for these programs or competitions when they are published in the *Federal Register*.

The Office of English Language Acquisition (OELA) anticipates conducting three competitions under the Foreign Language Assistance Program for Fiscal Year 2009:

LEA-IHE Partnerships (84.293A)

This program supports Local Educational Agency (LEA) projects that work in partnership with one or more Institutions of Higher Education (IHEs) to establish or expand articulated programs of study in foreign language learning that exclusively teach one or more of the following languages critical to United States national security--Arabic, Chinese, Korean, Japanese, Russian, and languages in the Indic, Iranian, and Turkic language families. Such programs must be designed to enable successful students to achieve a superior level of proficiency in those languages as they advance from elementary school through high school and college. Schools, private schools, colleges, universities, and individuals are not eligible entities for this program. Charter schools that are considered LEAs under State law are eligible to apply. An intermediate unit within a State (e.g., a Board of Cooperative Educational Services (a BOCES), assuming it meets the definition of the term local educational agency, may apply for and receive a grant.

In making a decision about applying for an LEA-IHE partnership grant, a school district should consider if it intends to:

- Serve critical languages *exclusively*
- Develop an articulated, sequential program of study from elementary school through high school
- Develop a program of study that is designed to enable successful students to achieve a superior level of proficiency
- Establish partnerships with one or more post-secondary institutions that provide instruction in the critical languages to be served by the project.

If a district's proposed plan does not meet the above conditions, it should consider applying instead under the LEA (84.293B).

LEA Grants (84.293B)

This program provides grants to establish, improve, or expand innovative foreign language programs for elementary and secondary school students. In awarding grants under this program, the Secretary of Education supports projects that: (a) show the promise of being continued beyond their project period and (b) demonstrate approaches that can be disseminated and duplicated by other LEAs. Schools, private schools, colleges, universities, and individuals are not eligible entities for this program. Charter schools that are considered LEAs under State law are eligible to apply. An intermediate unit within a State (e.g., a Board of Cooperative Educational services (a BOCES), assuming it meets the definition of the term local educational agency, may apply for and receive a grant.

SEA Grants (84.293C)

The State Educational Agency (SEA) program provides grants to establish, improve, or expand innovative foreign language programs for elementary and secondary school students. In awarding grants under this program, the Secretary of Education supports projects that promote systemic approaches to improving foreign language learning in the state. Local school districts, schools, private schools, colleges, and universities are not eligible entities for this program.

Definition of a "local educational agency"

The term "local educational agency" means a public board of education or other public authority that maintains administrative control of public elementary or secondary schools in a city, county, township, school district or other political subdivision of a state.

Definition of an "institution of higher education"

The ESEA, at Section 9101, defines an IHE as follows:

"(24) INSTITUTION OF HIGHER EDUCATION- The term institution of higher education' has the meaning given that term in section 101(a) of the Higher Education Act of 1965."

Section 101 of the Higher Education Act of 1965, 20 USC 1001 provides that:

"(a) Institution of higher education

For purposes of this chapter, other than subchapter IV, the term "institution of higher education" means an educational institution in any State that-

- (1) admits as regular students only persons having a certificate of graduation from a school providing secondary education, or the recognized equivalent of such a certificate;
- (2) is legally authorized within such State to provide a program of education beyond secondary education;
- (3) provides an educational program for which the institution awards a bachelor's degree or provides not less than a 2-year program that is acceptable for full credit toward such a degree;
- (4) is a public or other nonprofit institution; and
- (5) is accredited by a nationally recognized accrediting agency or association, or if not so accredited, is an institution that has been granted preaccreditation status by such an agency or association that has been recognized by the Secretary for the granting of preaccreditation status, and the Secretary has determined that there is satisfactory assurance that the institution will meet the accreditation standards of such an agency or association within a reasonable time."

Definition of a "state educational agency"

Section 9109(41) of the Elementary and Secondary Education Act defines a State Educational Agency as "the agency primarily responsible for the State supervision of public elementary schools and secondary schools." 3/24/09
