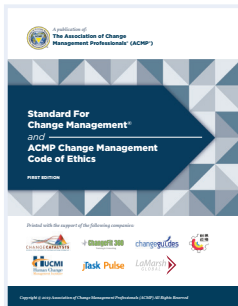

The ACMP Standard for Change Management is a collection of generally accepted practices in change management and is one of the foundational elements in advancing the change management profession and discipline. Released in September 2014, the Standard provides the foundation for the Certified Change Management Professional (CCMP) credential, the Qualified Education Provider™ (QEP™) Program, and empowers change practitioners to lead the way change works.

- A definition of practices, processes, tasks and activities
- Guidance for organizational change management, for any type of change
- Generally accepted practices and processes used by practitioners across industries, organizations and roles
