

It is not a coincidence that the founders of both organizations at totally different times and locations dreamt of two separate organizations with continuing education being their cores. That is what distinguishes these two organizations from others and they need not forget that distinction or lose it altogether.

It is commitment to a higher purpose of service and achievement that both organizations espouse to through continuing education. It is a lifelong process of achievement and pride.

Dentists are a generous lot. They are generous with their time and resources. They are generous with their knowledge and expertise. They give, they share, they participate and they care. This care goes above and beyond our boundaries and spills over to other disadvantaged in other countries. That is an honorable goal, to help those that need help and to teach those that can render help. But here is the catch; we are so quick with helping others that sometimes we forget about our own backyards, our own urban areas, and our own underserved areas.

Here at home, they talk of Dentist shortage. They talk of inadequate distribution of dentists or misdistribution of dentists.

They talk of inadequate delivery systems and then try to remedy that by instituting and developing substandard criteria for training care givers. They think the answer is to introduce another tier of provider known by many names but are all categorized as mid level providers.

Mid level providers may be necessary for third world counties or underdeveloped countries or those countries that do not have enough dentists to provide care for their population. Here at home we are neither a third world country, nor an underdeveloped country and we have the necessary number of dentists to provide all the necessary care to all our population contrary to our antagonist 's belief. Yet those same people are advocating lowering the standard of care contrary to what the ADI and the AGD stand for which is the elevation of dental standards by continuing education. They ignore the fact that here at home so many dental schools have opened their doors and many more are planned. According to ADEA five accredited dental schools have opened, three new dental schools are seeking accreditation and 15 new dental schools are under consideration. In the very near future there will be a

surplus of young graduates to serve, treat and assimilate into the populace. Let us help these graduates in establishing their offices, forgive some of their astronomic student loans, and give them incentives to practice in the underserved areas and all these doubters and naysayers will go away.


