Special Interest Alliances – network to discuss common interests and best practices





EMAIL SUBSCRIPTIONS/NOTIFICATIONS

You will NOT be automatically subscribed to receive email notifications to the AHDI forums. Since this can significantly increase your email volume, subscribing is voluntary. See the instructions below on the subscription options and how to manage your preferences.

HOW TO SUBSCRIBE

Within each SECTION, you have two levels of subscription options:


- A. **Forum Level**: receive an email when new topics are added to the forum and/or receive a daily email digest.
- B. Topic Level: receive an email when new comments are made to a discussion thread.

You will need to subscribe to each level separately:

- 1. Navigate to the Forums page.
- 2. Click on the name of a Forum.
- 3. **To subscribe to the Forum Level**, select the Forum Actions button and select "Subscribe to Instant Updates" and/or "Subscribe to Digest." You will be notified when new topics are added to the forum according to the option(s) selected. The digest only includes information about new topics created within the forum.



4. **To subscribe to the Topic Level**, click on the name of a topic. Select the Thread Actions button and select "Subscribe to Instant Updates." You will receive an email when new comments are added to this discussion thread. Repeat for all topics as desired.



GUIDELINES FOR PARTICIPATION

To ensure the best possible experience for all participants, we have established some basic guidelines for participation.

By participating in AHDI Online Forums, you acknowledge the following:

- You agree not to post material that is abusive, offensive, defamatory, or illegal. The discussions on the lists are meant to stimulate conversation, not contention.
- You agree not to post commercial messages (e.g., advertisements, product/service promotions).
- You agree to share information at your own risk. AHDI cannot ensure confidential material to remain solely in the online forum.
- You agree to post your message only to the most appropriate forum(s). Do not spam several forums with the same message.
- You agree to make a good faith effort in providing well-researched and/or verified information when responding to professional practice questions.
- AHDI and participants have the right to reproduce postings to the online forums.
- You have read and agree to the legal policies, disclaimer, and agreement below.
