Bruce has been actively involved with AHMP since 2006 when he joined the National Capital Chapter. From that point on, he has been involved with AHMP at the local and national level. He has assisted with the coordination of Annual Conferences, developed websites, held positions of National Capital Chapter Treasurer, Secretary, and Cyber Chapter President. He has been an active member of national committees, coordinated the EHMM course at the National level, participated in the writing and review of the 3rd Edition of the Desk Reference, and coordinated the development of the current version of the Essentials of Hazardous Materials Management course. This work clearly embodies the Mission of AHMP.

To provide opportunities to gain and share knowledge about hazardous materials management, create gathering places (communities) and a voice for professionals with common interests in hazardous materials management and provide management support for smaller communities of hazardous materials professionals.

Organizational Collaboration:

Bruce Donato is active on a number of other organization’s boards including the American Society of Safety Engineers, the American Industrial Hygiene Association, the Washington Metropolitan Area Construction Safety Association, and the Chesapeake Area Biological Safety Association. Bruce’s connections include many upper level personnel at NIOSH and OSHA. Bruce has utilized these associations and connections support AHMP in many ways including providing one of this year’s keynote speakers at the 2016 Annual Conference.

More importantly, the opportunity that these associations bring to AHMP is invaluable. Bruce routinely provides insight into how other EHS&S organizations operate, engage members, manage Chapters and hold events. In turn, gaining these insights helps AHMP to observe other ways of doing business.

AHMP History and Contributions:

Bruce Donato’s first experience with AHMP began in 2006 as a new member of the National Capital Chapter. He offered to be the Chapter Secretary, but he could not hold office because he was not a CHMM and thus not a certified member of AHMP. That did not stop him, he immediately started the process to obtain his CHMM.

In 2007, he attended and was a major participant in planning and holding the AHMP annual conference which was held in Washington DC. On a very hot day, he participated in the emergency response scenario playing a victim and nearly became one. He was left on the hot asphalt parking lot for quite some time. He also became a member of the Professional Development Committee during that conference. Bruce was the primary presenter for the AHMP’s Essentials of Hazardous Materials Management course taught at the same conference.

Bruce’s first AHMP award, Friend of the Academy, came in 2008 for his integral support for the 2007 Conference and the National Chapter, presentation of the EHMM course.

In 2008, Bruce become more and more involved with AHMP and the National Capital Chapter, serving as both chapter treasurer and secretary and he also developed a website for the National Capital Chapter. He developed remote meeting protocols and taught these protocols to Chapters ant AHMP’s 2012 Delegate training at the National Conference.

As of 2012, Bruce was assigned the role of national EHMM coordinator for the conference held in Anchorage. Bruce joined the CDC and participated in Chapter delegated training at the conference presenting new technologies and how they can help chapters reach out ot more members.



In 2013, Bruce wrote two chapters and reviewed ten chapters for the 3rd Edition of the Hazardous Materials Desk Reference. He also supported the developed the first errata sheet the 3rd Edition. That same year, Bruce was awarded his second AHMP Award, Hazardous Materials Manager of the Year, for his work in 2012 for the AHMP organization and the National Capital Chapter.

In 2014, Bruce lead the effort to update and upgrade one of AHMP's most significant professional development and a revenue generating programs, the Essentials of Hazardous Materials Management (EHMM). Bruce coordinated the development of the course, finding subject matter experts to write modules, reviewing material, managing the branded look and feel of the course, teaching or overseeing three beta versions of the course to fine tune material and assure its quality. And, finally, he was able to make it consistent with the 3rd Edition of the Hazardous Materials Desk Reference. This effort took well over a year to complete. This new course has revitalized the presentation of the course and brought new Chapters into the program.

In 2015, Bruce championed the revitalization of AHMP's Cyber Chapter and is the Chapter's President through the end of 2016. Bruce has participated on a number of AHMP national committees including the newly formed Conference Committee and is now a driving force behind many of AHMP's programs. Bruce taught or oversaw the beta test of the EHMM course (mentioned above). Bruce developed a new Letter of Agreement for the EHMM Course and manages the updates recommended for the course provided by Chapters and their EHMM presenters.

Also in 2015, Bruce stepped in as acting Executive Director after AHMP's Executive Director left the organization with no notice. While this was a paid position, AHMP would not have been able to continue managing member and Chapter services without him stepping into this role immediately. Bruce learned office management processes and directed AHMP's temporary staff. As acting Executive Director, Bruce worked tirelessly to manage AHMP's day-to-day business operations, supervised personnel, and managed financial and tax issues, vendors and contractors, all while continuing to manage his own personal business and continuing to support his many Committee and Chapter volunteer activities for AHMP, AIHA and ASSE. Without Bruce's steadfast support, the sustainability of AHMP would have been in question.

And finally, Bruce is a key resource to AHMP. He brings a wealth of knowledge on association management, information technology, and chapter operations that benefits AHMP in so many ways.
