## Annual Dues

Membership is categorized by the role your company plays in the automatic identification and data capture technology industry.

**Non-AIDC:** Member company (or named division of a company) whose primary business is selling products or services that are not automatic identification and data capture technology

**Academic Member:** An academic institution

**Government Member:** Government entity

**Nonprofit Member:** A registered nonprofit organization

**Introductory Member:** A company whose yearly revenue is or is anticipated to be less than \$3M/year. Membership at the Introductory Member level is limited to one year.

**User Member:** A company (or named division of a company) that does not sell but rather uses automatic identification and data capture technology in the course of its business

Annual dues are based on your membership category.
