ANDREW LATRELL RECEIVES ALLTRICITY NETWORK'S 2024 EMERGING LEADER AWARD

Andrew (Drew) Latrell, Civil & Transmission Engineer V, Colorado Springs Utilities, is a recipient of the Alltricity Network 2024 Emerging Leader Award. The award was conferred during the 2024 Alltricity Network Spring Management, Engineering, and Operations Conference held May 20th-22nd in Denver, Colorado.

The Emerging Leader Award recognizes and honors Alltricity Network members who are high potentials in their company and have 5-10 years of experience in the industry, establishing significant contributions within their organization and have demonstrated the potential for leadership and continuing service in the electric utility industry.

Drew joined Colorado Springs Utilities (CSU) in 2017 and is a Principal Engineer on the Electric Advanced Design team. In this role he is responsible for the design of the civil-structural aspects of substation and transmission projects as well as owner's representation for consultant led design. He also engages with the Planning and Operations teams on new project evaluation, estimating, and construction support.

Drew is quick to volunteer to provide support across CSU. Recently he volunteered as his department's representative for the Employee Action Team to take forward employee input to executive leadership. Through project meetings, his knowledge and quality work has captured attention and has led to regular presentations to leadership, including presenting to CSU's Utility Board. Drew has guided, trained, and mentored other civil engineers within the Electric Advanced Design team. The SEP effort has also now spanned years, and he continues to play a lead role within the full scope.

He frequently receives support requests from field crews, development services, transmission planning, emergency response, city infrastructure, infrastructure maintenance, and leadership, on top of regular projects assigned. These requests have been so recurring, that it may be easy to assume these are within his duties, but most of these requests fall outside his responsibilities. His contributions have simply become so noticeable that many groups see him as THE structural civil engineer to reach out to for miscellaneous requests. These duties expand across a wide range of

tasks not just limited to the electric utility but also CSU's natural gas and water service lines. His knowledge and professionalism have contributed to a higher appreciation of structural considerations across all utilities infrastructure.
