# DRAFT MINUTES Boards of Health Section Meeting Friday, February 4, 2025 – 1 p.m. – 4 p.m.

#### 1.0 CALL TO ORDER/LAND ACKNOWLEDGEMENT/WELCOMING REMARKS/INTRODUCTIONS

The BOH Section Vice Chair, T. DeGiovanni, called the meeting to order at 1:01 p.m., providing welcoming remarks and introductions to Boards of Health (BOH) Section members, Affiliates, speakers, and moderators and noted the consent agenda.

### 1.1 Land Acknowledgement

The Land Acknowledgement was read by T. Sachowski.

## 2.0 ALPHA UPDATE/SECTION BUSINESS/APPROVAL OF MINUTES Approval of Minutes

T. DeGiovanni called for a motion to approve the minutes from the November 8, 2024, BOH Section Meeting. The motion to accept the minutes as presented was approved and carried. T. DeGiovanni then turned the meeting over to alPHa's Chief Executive Officer, L. Ryan.

#### **Section Business**

- L. Ryan acknowledged the volunteer efforts of the BOH Section Executive Committee members, noting they continue to play an important leadership role in alPHa's work, and highlighted their participation in alPHa Board of Directors, alPHa Executive Committee meetings and in the BOH Section Executive and general meetings of the Section.
- L. Ryan then encouraged BOH Section members to read alPHa's monthly newsletter, *Information Break*, especially *Leader to Leader* (which is the alPHa Chair's message) and the BOH Resource section. She then turned the meeting over to T. Sachowski, Chair of the alPHa Board of Directors.
- T. Sachowski noted the BOH Section election process is being updated because of Ontario's Notfor-Profit Corporations Act. She then gave an overview of the process to fill open seats on the BOH Section Executive Committee and the alPHa Board of Directors.
- L. Ryan provided BOH Section members with an overview of alPHa's BOH Governance Courses. She also thanked M. Turner for co-presenting and for her work on the courses. L. Ryan noted the two courses offered: BOH Governance and Social Determinants of Health and gave an overview of each. She then provided BOH Section members with an alPHa orientation.
- L. Ryan also spoke about the Distinguished Service Awards. She encouraged the BOH Section members to send in their nomination. T. Sachowski noted the conference is a wonderful networking opportunity and is a chance for BOH Section members to meet their colleagues, share ideas, knowledge, and resources, and to celebrate public health.

#### 3.0 MEET THE NEW CHAIRS

L. Ryan introduced the representatives from the newly merged public health units. They were J. O'Neill from South East Health Unit, M. Boileau from Northeastern Public Health, R. Black, from Haliburton Kawartha Northumberland Peterborough Health Unit, and J. Bell from Grand Erie Public Health. Each spoke from their experience with merging health units - what had gone well, any challenges they had, and what they learned.

C. Doris then moderated the question-and-answer session. L. Ryan thanked them all for participating.

#### 4.0 BOARDS OF HEALTH – ROLES & RESPONSIBILITIES

L. Ryan introduced J. LeNoury, Principal, LeNoury Law and alPHa's Legal Counsel, D. Lawrance, Chair, Board of Health Northwestern Health Unit, and A. Kungl, Chair, Board of Health, Simcoe Muskoka District Health Unit. It was noted this session was about supporting those who serve on boards of health to better understand their roles and responsibilities as public health officials, and to keep them updated on legal requirements.

J. LeNoury provided BOH Section members with information regarding liabilities for boards of health and with an overview of their legal requirements. This included BOH governance, the HPPA, BOH responsibilities, and issues to address in order to govern effectively, highlighting best practices.

A roundtable discussion amongst J. LeNoury, A. Kungl, and D. Lawrance then took place, followed by an interactive session with those in attendance, moderated by L. Ryan. L. Ryan thanked J. LeNoury for the presentation and the panelists for participating.

### 5.0 ASSOCIATION OF MUNICIPALITIES OF ONTARIO (AMO) UPDATE

L. Ryan introduced A. Neufeld, Senior Manager, Policy, and D. Spagnuolo, Policy Advisor, from AMO. A. Neufeld explained that the presentation would be focusing on AMO's latest study that was released in January. She gave an overview of the project, noting 47 municipal service managers had contributed to the study. A. Neufeld and D. Spagnuolo's presentation covered three areas: 1. A new look at homelessness in Ontario, 2. A 10-year perspective on homelessness, and 3. Investing in solutions.

L. Ryan then moderated the question-and-answer session and then thanked A. Neufeld and D. Spagnuolo for attending the meeting.

#### 6.0 WRAP UP & NEXT MEETING

L. Ryan thanked P. Roumeliotis, K. Hébert, and A. Morrisson from the Eastern Ontario Health Unit and O. George from the Dalla Lana School of Public Health for their technical support. She recognized and thanked all of the speakers, workshop presenters, moderators and the alPHa staff: G. Fleming, M. Dziengo, and L. Russell for their work on the events over the week.

L. Ryan reminded BOH Section members to fill out their after-event surveys. She spoke about the alPHa 2025 Annual General Meeting and Conference, which is being held, in-person, June 18-20 in Toronto and noted that more information about the AGM and conference will be released in the next week.

L. Ryan adjourned the meeting at 3:49 p.m.
