American National Standards Committee A-14 Safety Code for the Construction, Care and Use of Ladders

SCOPE:

The Scope of the Committee is to develop requirements governing the safe design, construction, testing, labeling, selection, care and use of various common types of ladders. These would include, but are not limited to Fixed, Job-Built, Portable, Attic Stairs and Extreme Duty Rated ladders as well as mobile ladder stands, mobile ladder stand platforms, and ladder accessories.

It does not include ladders for mines, the fire service, mobile equipment, work platforms, antenna communication towers, transmission towers, utility poles, chimneys; and similar specialized applications nor are the labeling requirements and contents of the labels intended to include situations where training, supervision, or established safety procedures serve in lieu of such labeling requirements.

It does not evaluate specific ladders or laboratory findings of specific ladders, nor does it certify ladders or accredit the testing protocol of laboratories using the standard for certification or other purposes.
