AMERIPEN VOTING MEMBERSHIP APPLICATION

MEMBERSHIP REQUIREMENTS

An applicant for voting membership must be a legal business entity, for example a corporation or a limited liability company, conducting business in North America. For clarity, individuals, non-profit organizations and government entities do not qualify for voting membership.

The following shall apply to the application and all annual renewal applications.

(1) A parent company otherwise eligible may apply for membership, and if accepted, only the parent and not any of its subsidiaries shall become the member. For purposes of establishing the classification of membership, the worldwide sales of the parent company shall include all of its subsidiaries.

(2) If a parent company otherwise eligible does not apply for membership, any one of that parent company's subsidiaries may apply for membership, and if accepted, only that one subsidiary, and not the parent or its other subsidiaries, shall become the member. For purposes of establishing the classification of membership, the worldwide sales of the parent company shall be attributed to the applicant subsidiary.

(3) If a parent company is not eligible for membership, any one of that parent company's subsidiaries otherwise eligible may apply for membership, and if accepted, only that one subsidiary, and not the parent or its other subsidiaries, shall become the member. For purposes of establishing the classification of membership, the worldwide sales of the parent company shall be attributed to the applicant subsidiary.
