Summary: Discusses culturally competent health care, which embraces each individual's cultural beliefs, values, and customs, rather than imposing one standard of behavior and belief upon everyone. Explores how cultural beliefs and values affect the quality of health care. Topics include beliefs about illness and disease, gender roles, sexual orientation, personal and social space, touch, communication styles, time orientation, the use of gestures, appropriate forms of address, language differences, literacy, diet, and the importance of cultural assessment tools.

They will share what was required and what actions they took to move through the common first stages of denial, defensiveness, guilt, fear and shame into making solid commitments towards ending racism. The video uses art, theatre, movement, photographs and music to amplify stories that share richly varied experiences and life processes informed by deep reflection and social justice action.
