



Tracy Wolff, M.D., M.P.H., Scientific Director

Dr. Wolff is the Scientific Director of the U.S. Preventive Services Task Force (USPSTF) Program at the Agency for Healthcare Research and Quality (AHRQ). Dr. Wolff assists the USPSTF in the formulation of recommendations on preventive services provided in primary care settings. This assistance includes providing oversight of the USPSTF's efforts in translating evidence into guidelines and peer review of the USPSTF systematic evidence reviews and products. She is the lead author on several evidence reviews commissioned by the USPSTF. Over the last 11 years, she has collaborated with the USPSTF in the advancement of its methods for developing evidence-based recommendations, focusing on making recommendation for older adults, challenges in using evidence on intermediate health outcomes, and challenges in making recommendations for diverse populations. Dr. Wolff has received several awards for her work at AHRQ, including the Secretary's Award for Meritorious Service. Dr. Wolff completed a family medicine residency at the University of Maryland and a preventive medicine residency at Johns Hopkins University. She received a Master of Public Health degree from Johns Hopkins University with emphases on health policy and planning and maternal and child health.
