Candidates should have a Ph.D. in finance, real estate, urban economics or a related field. The committee will consider candidates at all levels (Assistant, Associate, Full, and Endowed Chair). The Real Estate Department offers courses in the School's BBA, MBA and MS programs. The position will begin Fall 2019.
