



## IGP Governance Board Roles / Responsibilities

The IGP program is governed by the IGP Governance Board, which is incorporated separately from the ARMA International Board of Directors. The IGP Board guides the certification program, provides outreach to the profession, and clearly separates the functions and decisions related to certification from other ARMA International programs and goals.

Its charter requires the IGP Governance Board to ensure the credibility of the credential through establishing processes and oversight. Specific responsibilities include:

- Ensure the validity of the exam
- Provide fairness so all applicants and candidates are treated impartially
- Provide qualification requirements for applicants
- Provide maintenance requirements that ensure continuing competence of individuals who hold the credential
- Ensure public trust in the methods and processes used by the IGP credentially program
- Ensure the administrative credibility of decisions and actions taken
