 Session starts January 8 and has a constitutionally required adjournment date of May 20, 2019.

- April 13 through April 22 is the Easter/Passover break for legislators.

DHS has submitted a final report to the Legislature regarding mental health reimbursement rates. AspireMN member involvement in this process was fundamental and allowed us to form the basis for our *Say Yes & Invest* initiative, which will seek a rate increase and establish a rate methodology for the future. This is Medicaid statement on the Health Care Provider Tax

In December, the *This is Medicaid* coalition distributed their official statement supporting the "continuation of the health care provider tax, or timely implementation of a reasonable and sustainable alternative, to maintain the Health Care Access Fund." You can read it here.

Federal Government Shut-down – implications for healthrelated initiatives

But seven bills are outstanding — including those that fund the Interior, Agriculture and Justice
