**Selection and eligibility:** Each year the advisory board of the Denise Henning Connections Program selects 6 mentee participants. Participants must be current members of AWL before the first meeting in January 2020 and must commit to attending all Connections events, as described below under “Required Meetings.”

**Terms of Program:** The 2020 Class of the Denise Henning Connections Program will meet for 3 years, 2020-2022.

**Required Meetings:** Participants in the Connections Program meet once a month. Group meetings take place beginning in January 2020 and occur 6 times per year in the odd number months. One-on-one mentor/mentee meetings take place on even number months beginning in February 2020. Attendance at all meetings is a required component of the program to ensure its success. Participants typically receive the entire year’s calendar of group meeting dates at or before the January 2020 group meeting. Individual mentor/mentee meeting dates are planned by the mutual agreement of the mentor/mentee. Because the Connections Program is free to mentees, mentees must commit to attending at least one event that raises funds for AWLF during the 3-year program.

**Cost:** There is no cost of the program to mentees. The program is funded by the generosity of mentors. This includes paying any costs associated with the mentor/mentee one-on-one meetings.
