The Association for Women Lawyers of Greater Kansas City (AWL) is pleased to offer its annual **2018 Roxanne Barton Conlin Scholarship Award**. This year AWL plans to award the following to one female law student from an area law school:

1. A **\$2,000.00 scholarship;**
