Responses in this Application will be used as factors to determine whether or not AWL Board Members will approve an endorsement of the applicants. If your responses will not fit within the spaces provided, please securely attach additional pages to the application. Applicants seeking AWL endorsement must complete this application each time they apply for a judicial vacancy or other position. Upon completion of the following application, please submit the signed application along with your CV or resume to the judicial chair no later than 5:00 p.m. on the seventh (7) day after the panel is announced.
