

# Affiliate Membership Application



The Arizona Association for Home Care (AAHC) is a nonprofit 501(c)6 organization.

## Eligibility:

Affiliates are individuals, companies/organizations that are not eligible for Provider Membership but support the purposes of AAHC.

## Membership Categories:

- **Vendor:** A company/organization that provides products or services to the Home Care Industry.
- **Associate:** A company/organization that provides in-home services (i.e. private duty, transitional care) but is not required by DHS to be licensed as a Home Health Agency.
- **Individual\*\*:** A person with an interest in the purposes of AAHC.
- **Student\*\*:** A person with an interest in the purposes of AAHC that is enrolled in an accredited school of higher learning.

\*\*Persons that are affiliated/employed with a company that is eligible for membership may not be Individual or Student Members unless the company is a Member.
