Cancellation of 2026 Exhibit Space or Sponsorship

If AzNA does not receive any notice of cancellation in writing, the exhibitor will be liable for 100% of the total fee as submitted on the Exhibitor Registration Form. A completed registration form and payment must be received in order to attend. Exhibitors who are present without payment will NOT be given space in the exhibit hall.

Exhibit Table Cancellation: Written notice of cancellation received prior to July 6, 2026 will incur a \$50 administrative cancellation fee. Cancellation notice received on or after July 6, 2026 is subject to 100% of total fee amount as submitted on the Exhibitor Registration Form.

Sponsorship Cancellation: If written notice of cancellation is received prior to June 1, 2026, sponsor agrees to pay an administrative cancellation fee of \$50. Written notice of sponsor cancellation received on or after June 1, 2026 will result in a cancellation fee equal to 100% of the total amount as submitted on the Exhibitor Registration Form for space, sponsorship or other materials.
