Code Enforcement Officers risk their lives to uphold the public health, safety and general welfare standards that protect people, property values, and the environment.

This document outlines the two California bills currently in the State Senate designed to protect Code Enforcement Officers, why officer safety matters, and the dangerous incidents, including murders, that have happened to code enforcement officers.

Code Enforcement Officers are urged to take action to ensure Senate Bills 101 and 296 are signed into law. Now more than ever, we must ensure our elected representatives understand that our safety matters.

Officer Safety Bills in the California Legislature

Senate Bill 101 The DMV Bill (Senator Jim Nielsen)

SB 101 would close the loophole in existing law to prohibit disclosure of home addresses of code enforcement officers (note: parking enforcement officers are already covered by law).

SB 101 will include all Code Enforcement Officers under the protections of California Vehicle Code Section 1808.4. It is an important, added layer of safety that will help assure that all Code Enforcement Officers will have their DMV information secured. It bears repeating that there is no difference between the dangers facing Code Enforcement Officers who are currently covered under the law and those Code Enforcement Officers who currently are not currently covered.

Senate Bill 296 The Code Enforcement Officer Safety Standards Bill (Senator Monique Limón)

SB 296 would require cities and counties to establish safety protocols specific to code enforcement officers and specific to the risks posed in the particular jurisdiction.

Currently, many jurisdictions do not have safety programs to train and protect code enforcement officers from threats, assaults, batteries, or worse. Due to recent changes in State and local law, many code enforcement officers have been given the responsibility of dealing with community problems that were traditionally handled by sworn peace officers. These duties include, but are not limited to, the abatement of hard drug houses, illegal cannabis grow operations, red-light district activity enforcement and abatement, and other criminal behaviors. Sworn peace officers are well trained in officer safety and have many legal protections under State and local law. There are requirements already in place that require jurisdictions to establish specific safety protocols for sworn personnel however, none exist for code enforcement officers. This bill would change that.

Code Enforcement Officer Safety Incidents

Below are excerpts from some of the many officer safety incidents reported to CACEO



During the investigation, the transient pursued the code inspector with a machete. The code officer made good on escape.

Code Officer was punched by a business owner while he was conducting Covid enforcement.





A man in his 80's began hitting the Code Officer with a metal pipe. As the Code Officer retreated, the man start spitting at him. After citing a salon owner, a Code Officer was returning to his vehicle when the salon owner hit him with her car intentionally.

I received a call from detectives stating they received a creditable threat against my life. The investigation is ongoing. A disgruntled citizen took photos of the personal vehicles of Code Enforcement staff that were parked at the office. The citizen zoomed in on the personal license plates of the Code staff vehicles and posted each photo on Craigslist noting threats that should be made.





Suspect stated to one of his friends that he would kill any code enforcement officer that comes to his home. The threat was made while he pointed a loaded shotgun at his friend and stated that he would kill him too.

After explaining I was with the County and investigating a complaint of un-permitted grading, the individual told me that I had better leave them alone or I would be buried underneath one of the marijuana plants.
