

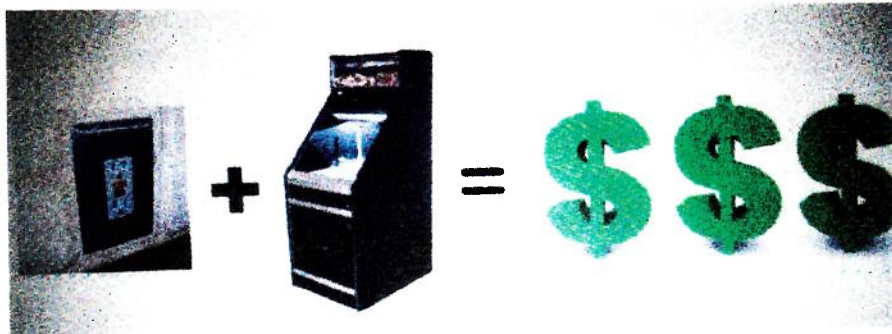

Well, the California State Lottery and the California Department of Justice completely omit any mention of this second exemption qualifier in the commonly distributed Law Enforcement Advisory 10.

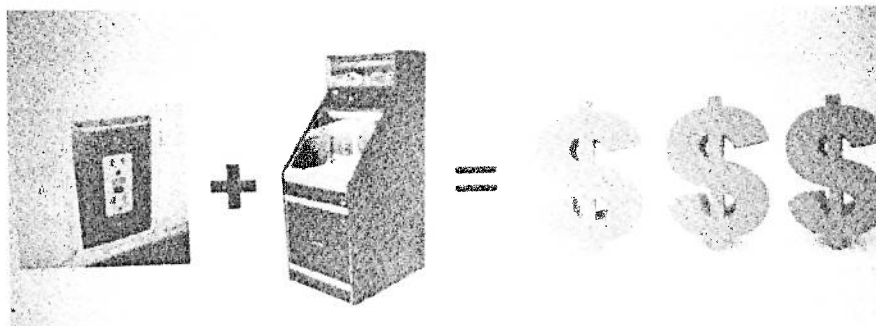
