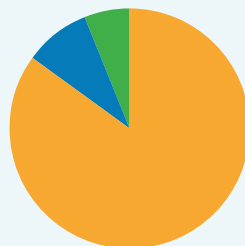

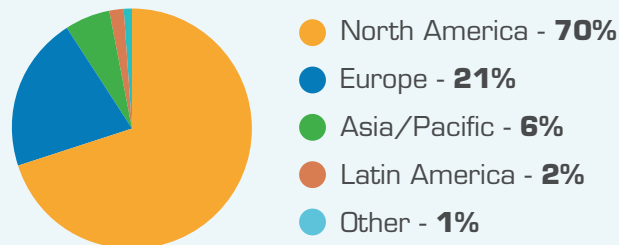

PROFESSIONAL REPRESENTATION

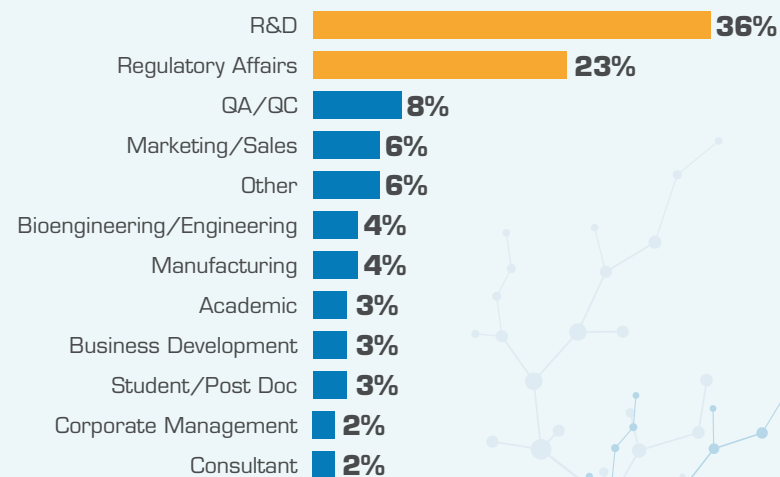
