

## CARLETON MEDAL RECIPIENTS

The Carleton Medal is given to a lawyer (including a retired lawyer, judge, former judge, or paralegal) who is most deserving of recognition for great diligence, high ideals and outstanding leadership in the practice of law throughout their career. Those who will receive the medal will have made a significant contribution to the profession of law, whether as a solicitor in effectively performing services in that position, as a barrister in attaining an excellent reputation in the courts, as an academic, or for a single act of notable distinction that advances the ideals of the profession. The medal will be awarded only to a member or former member of the County of Carleton Law Association.

The Carleton Medal was first struck in 1988 for the Centenary of the County of Carleton Law Association. The medal was designed by Kenneth Jarvis, Q.C., a former LSUC Treasurer, and struck by Medallic Art Company in Sioux Falls, S.D.
