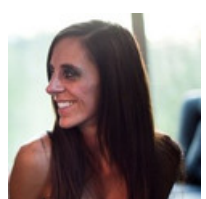


#### **BILLY WALSH** - Manager, Technology (Insurance Transformation), Deloitte
