As part of honouring Shane Godbolt who passed away at the end of 2019, HLG donated £2,000 in her memory. At Shane's wish the donations will be divided between Macmillan Nurses and African Hospital Libraries (AHL) which is the charity Shane has been supporting since she retired as Director of Partnerships in Health Information (Phi). Shane was an active advocate for health librarians and health librarianship and was founder-editor of Health Libraries Review, now Health Information & Libraries Journal.

Establishing HILJ as a Leader in Open Research was one of our themes for 2019 and HILJ is working to explore a planned, step-by-step adoption of some of the initiatives on Open Data, Open Collaboration and Open Recognition.

We were honoured to nominate Maria Musoke for her Fellowship award (HonFCLIP) and supported a joint ILIG/HLG informal to present her award and hear more about her work. Maria is in so many ways a trailblazer as the first Ugandan woman to obtain a PhD in Information Science, the first Ugandan woman to become a Professor of Information Science, the first Librarian from Sub-Saharan Africa to chair the IFLA Health and Biosciences Section, and the first Ugandan woman to head Makerere University Library Services.

On the same evening the K&IM Awards took place and we were delighted to support two fellow health librarians who were awarded the prize of UKeIG & K&IM Information Manager of the Year Award - Liz Hunwick & Sarah Lanney, Basildon and Thurrock University Hospitals Trust.

As CILIP evolves and changes, we have been involved in the Co-Design work to help shape strategy and business focus for CILIP as well as contributing to an Equalities Impact Assessment for the project.





POLICY

2019 Policy Update

The agreed objective for the HLG Policy work in 2019 was:

'To promote the value and role of health librarians to policymakers and external organisations'

Much of this work is conducted as part of the joint policy work of the Health and Social Care Strategy Group (HSCSG) convened by CILIP, SCONUL and Research Libraries UK.

Through this group, we respond jointly to public policy consultations and contribute to the thinking of key policy makers invited to join discussions with the group.

During 2019, HLG responded to the Green Paper to 'Advancing our health: prevention in the 2020s'. Within this response, HLG emphasised the role of libraries across sectors in: improving the health of people in poorer communities; supporting families with young children; promoting well-being and good mental health; and helping people to live healthier lives. HLG also suggested that good health choices depend upon health literacy, the ability to access, assess and apply health information. With an ageing population and increasing co-morbidities, people will have to make increasingly complex health choices.

CPD PANEL

2019 CPD Panel

2019 has been another busy year for the HLG CPD Panel. We have created two new working groups to take forward some suggestions received from our members. These working groups have been an excellent opportunity for our panel to work with HLG members outside of the committee, building new networks to support librarians working on systematic reviews and information professionals new to health libraries.

As part of HLG's AGM in 2019, we invited all members to attend a free summer workshop on using social media in libraries. This was facilitated by Andy Tattersall (ScHARR and Chair of CILIP Special Interest Group MmIT). In July, one of our co-Chairs represented HLG at the 2019 CILIP Conference. As well as promoting our special interest group (SIG) on the HLG stand, Lesley chaired the health libraries part of the programme featuring speakers we had helped select for this section.

In the Autumn, HLG ran our first webinar which was led by guest speaker Sue Lacey Bryant who kindly spoke to our members about the newly published Topol Report.

2019 was a great year for working with other SIGs. In October we were very pleased to be able to send a speaker (Rachel Gledhill) to speak at CILIP's Public and Mobile Library Group's (PMLG) annual conference on health literacy. This invitation came following HLG's previous work with PMLG on coordinating patient information workshops for health professionals working across the health and public library sectors. In November HLG once again collaborated with CILIP's International Library and Information Group (ILIG) to host an informal event at CILIP's headquarters. This year the event was focused on African Hospital Libraries (AHL) work in Sierra Leone. Speakers, Stevie Russell (Trustee) and Claire Blackrock (co-founder and Trustee), spoke to attendees about the ongoing activities of this charity.

Also in November, HLG held a face to face meeting of our CPD Panel. Members came together for a strategy day in London where business plans and objectives were formulated for the next two years. The CPD Panel was also pleased to welcome Sam Clary, Librarian at Mid Essex NHS Trust as a new member to the panel. The panel is looking forward to delivering a full programme of training events in 2020.

CONFERENCE

2020 Conference

HLG is busy getting ready for its 2020 Conference at the Macdonald Aviemore Resort, Cairngorms National Park, Scotland. It will take place on 24th - 25th July.

This year we are offering accommodation as part of the conference fees. Packages include Conference only, Silver and Gold. Gold offers 3 nights 4* accommodation and breakfast, conference pass, conference lunch & refreshments, drinks reception on Wednesday, gala dinner on Thursday plus dinner on Friday in a resort restaurant of delegates' choice.

Keynote speakers include Sean McNamara (Head of CILIPS, Scotland) and Ann Wales (Scottish Government eHealth Digital Health and Care Team). As part of the well-being agenda, Dance and Movement Psychotherapy featuring the Bishop and Le Fanu Lecture.

The programme features health library and information professionals talking about their ideas, projects, research and best practice.

Following feedback from Keele, HLG have reduced the programme thereby allowing delegates more time between sessions. The magnificent Cairngorms are just outside with plentiful opportunities for getting back to nature and finding your wild side.

Novus Marketing and Event Management are organising the conference again this year. Registration has been open sine January 2020 and thus far are exceeding expectations.

HLG NEWSLETTER

2019 HLG Newsletter

The HLG Newsletter continues to be published in electronic format and is made available through the CILIP website. Emails are sent out quarterly to HLG members, LIS-Medical list members, NHS regional LKS Development Managers and health library regional networks to call for content and notify readers of new issues.

Health Libraries Group Newsletter

Over the four issues of 2019, HLG received 16 articles reporting on good practice and experience, 5 reviews of library and information themed books and 6 event reports written up by attendees. Internet Sites of Interest, a column that brings together the top resources on specific topics, covered:

- Ebola
- Quality improvement in healthcare
- Social work and safeguarding
- Bacteria and bacteriology

The Newsletter also included information about relevant CPD events, international HLG updates and announcements about the HLG Conference 2020. All of these items were kindly written by our columnists, HLG members and wider CILIP members.

Looking to 2020, the Newsletter Editors are working with other HLG committee members to create an online information repository of past HLG activity as the old version of the CILIP website is taken down. The 'Current Newsletter' page on the HLG website accounted for approximately 13% of the overall traffic on the website (March 2019 - January 2020). The Editors hope the new online platform will allow for a stable repository to support better sharing of articles and to support group members' CPD.

HLG NURSING

2019 HLG Nursing

Three issues of HLG Nursing Bulletin were released in 2019; the first featured articles reflecting on the importance of library services from the point of view of users, and critiquing the process of wedding collections that can lead to old but important texts being disposed of. The second was based around conference reports with reflections of three of the attendees at the 2019 LILAC Conference, and a report from the 2019 Evidence Based Library and Information Practice Conference. Both of these issues features what will aim to be semi-regular book review articles as well, with the first two being reviews of 'Systematic Searching - Practical Ideas for Improving Results' and 'The No-Nonsense Guide to Leadership, Management and Team Working'. The final issue was dedicated as a tribute to Shane Godbolt and featured reprints of articles she had contributed to and which had been previously published elsewhere. It also contained a reminiscence article by one of her former colleagues from her time as librarian of Charing Cross and Westminster Medical School.

The Bulletin was previously embargoed to HLG members only. This policy has now changed to an embargo of twelve months worth of issues, with all issues previous to this period freely available. The Shane Godbolt tribute issue was made fully accessible from publication.

Work remains ongoing to build an online archive of NIS/LfN Bulletins. There is an open call for previous print issues to either be digitised by their owners and sent, or to be sent for digitisation.


HLG Nursing has become part of the wider HLG project to implement an overall website for HLG publications. This will encompass the online archive as well as potentially making articles within the current Bulletin more accessible through a capability to search and display them individually.

2019 Core Collections

The new 2019 edition of the 'Core Collection of Mental Health Books', supported by HLG and endorsed by the Royal College of Psychiatrists, has been published by Tomlinsons.



This 4th edition has been fully updated by the Psychiatric Libraries Co-operative Scheme (PLCS) committee based on the contributions of mental health librarians in the NHS, Higher Education and special libraries as well as health practitioners working in this field. The PCLS committee thank all contributors for their involvement, making it a truly collaborative publication.

2019 Health Information and Libraries Journal (HILJ)

The virtual HILJ edition produced to support the June 2019 EAHIL workshop, Basel had a total of 602 views (recorded via Bitly).

2019 Social Media

HLG Twitter account (<u>@ciliphlg</u>) gained a total of 166 new followers, and the total number of tweets and retweets amounted to 900. HLG maintained a presence on both #ukmedlibs and #uklibchat monthly Twitter chats.

2019 Website

Website statistics (March 2019 - January 2020) show the 'Current Newsletter' constitutes approximately 13% of the overall traffic to the HLG website. The newsletter as a whole constituted 6% of the overall traffic to the HLG website; HILJ 3% and HLG Nursing Bulletin 3%. The majority of newsletter pages are still on the old Drupal system; full migration to current YM platform by summer 2020.


Income for 2019 was £16,182.11.

Income


In 2019, the majority of income came at the end of the year from conference sponsorship payments for the 2020 conference. HLG also received the CILIP capitation. The other main form of income comes from commission from the sale of the Health Information and Libraries Journal (HILJ). The royalties for 2018 were delayed in reaching the HLG account and only cleared in February 2020, an amount of £20,561.
