#### Consent Calendar

#### **CMTA Audit**

Treasurer Leisz also reported that the budget will include funds for the 2020 audit. The board discussed the possibility of sending out an RFP for audit services to try and bring the fee down.

Michael Solorza reported that he is still working on a Southern Division conversations event, and is still working on confirming a speaker, but will update the board at the August meeting on progress. Damien Charléty also reported that he is working on a Northern Division event and should have additional information at the next meeting.

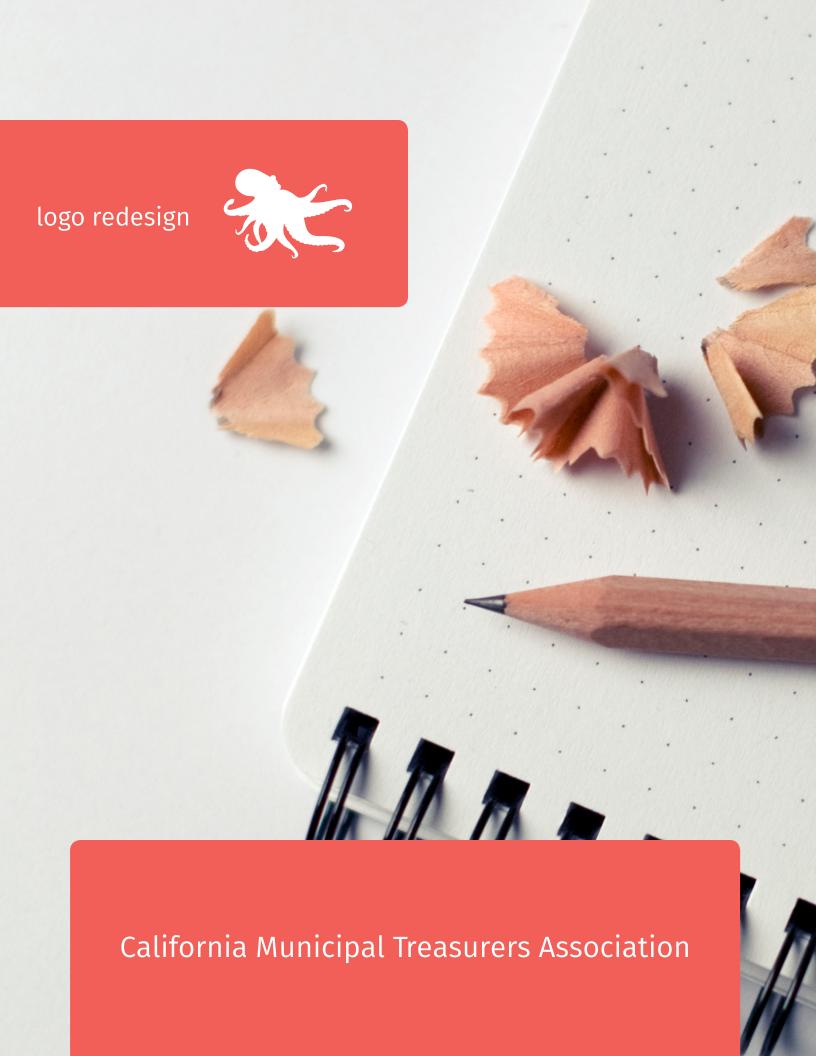

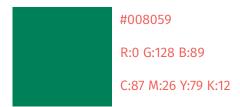
