Antitrust Statement - The Congress of Chiropractic State Associations reminds members that state and federal antitrust laws prohibit agreements among competitors which unreasonably restrain competition and that charges of antitrust violations are often based upon discussions among competitors regarding prices, price levels or price mechanisms, refusals to sell to certain customers, refusals to purchase from certain suppliers of products or providers of services, division of markets by customer or territory, or conditioning the purchase of one product or service upon the purchase of another product or service. No such discussions will be tolerated during this or any other ChiroCongress meeting. These guidelines apply not only to formal meeting sessions, but also to informal discussions during breaks and other conference events.
