President's Message

DR. MARK MANDELL-BROWN, PRESIDENT, AMERICAN ACADEMY OF COSMETIC SURGERY



It started with a simple cancellation email. Two Hong Kong-based lecturers for our 2020 Annual Scientific Meeting in Las Vegas notified me that they could not attend because

of a quarantine due to a virus. This occurred in early February, three weeks before the meeting. I *heard* but I did not *listen*.

I had first-hand knowledge of a pandemic that would soon affect not only cosmetic surgeons but the entire world, shuttering practices and cancelling operations while decreasing supplies of personal protective equipment, causing mass unemployment, and a crashing the stock market. Yet my concern was filling their speaker slots.

Thinking back to that moment, I wonder: how often do we as physicians *hear* but not *listen*? When our patients give us warning messages that we can never meet their expectations, do we listen? When our staff warn us of difficult patients, do we *hear* or do we *listen*?

One of my favorite listeners is Dr. Jean Carruthers. She not only *heard* a patient offhandedly describe the smoother eyelid skin after blepharospasm treatment with Botulinum A, but she *listened*, which led to fame, fortune, and the creation of the multi-billion-dollar neurotoxin cosmetic industry.

When it comes to the American Academy of Cosmetic Surgery, Board members and the Executive Committee need to not only *hear* what our members have to say but listen to their input.

Our members asked for ways to collaborate virtually during the COVID-19 pandemic. In response, we organized the AACS Connect series of free webinars for members to share ideas and learn about the small business protection plan enrollment as well as discuss protocols to re-open their offices.

We also want to provide the educational opportunities our members need while considering new social distancing measures. On August 22-23 in Chicago, we'll hold the <u>Hands-</u> <u>On Injectables Workshop</u> with course director Rania Agha, MD, FAAD, FAACS. Attendees will learn about the anatomy, products, and treatment indications associated with soft tissue fillers and neurotoxin injections while watching live demonstrations in a small group setting.

Finally, the printed <u>Member Directory</u> on its way to you this month is another response to strong demands from our members to have their colleagues' contact information at their fingertips.

We want to continue to listen to our members, but we can't do that if our members aren't engaged. I would encourage each of you to consider becoming more involved with AACS and <u>apply to join a committee</u> by June 30.

Committees including Marketing, Fellowship, Young Physicians, Women in Cosmetic Surgery, and more are open to those who believe they have ideas and experience that will help advance our academy.

Additionally, if you have office staff who want to get involved, encourage them to join AACS and direct them to the new Allied Health & Practice

Management committee, chaired by Marsha Steed and Gabriel Bellini, which will help us spread best practices for patient engagement and every aspect of running a cosmetic surgery practice.

2020 started out as a promising year but turned into a challenging one. Yet adversity is not new for our members, and through careful listening, we can make it through and strive to be even better in the end. (§

- Expanded Fellow-level membership criteria to include more international members
- Created three new committees: Women in Cosmetic Surgery, Young Surgeons, and the Allied Health & Practice Development Committee
- Updated the Bylaws to define Board Meeting attendance

In Memoriam: Dr. Robert Fragen

DR. ROBERT JACKSON, AACS PAST PRESIDENT



Ronald A. Fragen, MD, a founding member of the American Academy of Cosmetic Surgery and former member of the Board of Trustees, passed away on May 28, 2020 in Palm Springs, California.

I have known Dr. Ron Fragen since medical school at Indiana University School of Medicine. He was a couple of years ahead of me. I remember him as someone who made a freshman feel better about the rigors of that first year in school.

Ron was one of the pioneers of this Academy and dedicated himself to advancing education in cosmetic surgery. He served on the AACS Board of Trustees and planned many Annual Scientific Meetings and live surgery workshops as a longtime member of the Education Committee. He also served as an examiner for the oral exam for the American Board of Cosmetic Surgery.

Dr. Fragen was known for his dedication to teaching others. He taught current AACS President Dr. Mandell-Brown how to use the Iconoclast instrument for breast capsule surgery at one of my cosmetic workshops. Thereafter, Dr. Mandell-Brown and his office referred to the tool as the "Fragen Iconoclast" in honor of his teaching.

Most importantly, Ron was a dear friend and colleague. He and his wife Carol have so many friends in this organization who will feel a real sense of loss at Ron's passing. Dr. Ron Fragen was a good man, a good surgeon, a good father and grandfather, and a great friend. He will be missed by this Academy.

Dr. Fragen will be remembered for his influence on cosmetic surgery and his positive effect on the lives of all those who knew him.

Improve Your Patient Experience, Transform Your Practice

Update to CME Requirements for ABCS Certifying Exam

Did you complete an AACS or equivalent fellowship in cosmetic surgery some years ago? Did you NOT take the ABCS board certification exam due to the CME requirements for your post fellowship years? Then this update is for you. The ABCS has streamlined its CME requirements to help fellowship trained cosmetic surgeons sit for the ABCS certifying exam. At the May 2020 meeting, ABCS Board of Trustees approved the following CME requirements:

A candidate must submit proof of completion of minimum number of CME hours required per year to maintain their medical/osteopathic license in good standing in the state the candidate practices or maintains a medical/osteopathic license during the threeyear period prior to the year of application. Candidate must specifically identify a threeyear period prior to the year of the application. Candidate must specifically identify a minimum of 50% of said Category 1 CME credits in cosmetic surgery or related areas.

Update from the June 2020 AMA Meeting

On June 7, Tony Geroulis, MD, and Robert F. Jackson, MD, attended the American Medical Association (AMA) 2020 Annual Meeting as the AACS Delegate and Alternate Delegate. Here is their full report from the event. In addition to the June 7 meeting, Dr. Jackson chaired the Section Council of Plastic, Reconstructive, and Facial Plastic and Reconstructive Surgery's interview session on Saturday, May 30.

The AMA 2020 Annual Meeting was held in a virtual fashion, due to the COVID pandemic, and much of the House's usual business was shifted to the November Interim Meeting. The Speaker and Vice Speaker of the House did a superb job of making the meeting run smoothly.

Dr. Geroulis and Dr. Jackson collaborated on their votes. Dr. Geroulis was able to vote on all of the resolutions and candidates. Most of their AMA Board of Trustees candidates were elected. There was a contested election for members of the Council on Medical Services. Lynn Jeffers, MD, from our Section Council was elected in addition to Steven Chan, MD, MBA, a breast surgeon who is currently chair of the Surgical Caucus.

During the virtual meeting, <u>Susan Bailey, MD</u>, a pediatric allergist from Texas, was inaugurated as the new President of AMA. She is the third consecutive woman to hold the office and a good friend of Drs. Geroulis and Jackson. The meeting concluded with an instructive town hall meeting on the COVID-19 pandemic. Physicians currently serving on the front lines were thanked.
