Whereas: **Adela Salame-Alfie** has given 21 years of professional service to the State of New York in the Radiation Control and Environmental Health Programs of the New York State Health Department, where she served as Section Chief of the Environmental Radiation Section, Director, Bureau of Environmental Radiation Protection, Director, Division of Environmental Health Investigation, and Preparedness Director, Center for Environmental Health;

Whereas: During her years with the New York State Health Department's radiation control program, Adela has been a strong supporter of the CRCPD and Associate Member since 1993, and was the Director Member from 2003 - 2007;

Whereas: In her support of the goals and objectives of the CRCPD, Adela has served the organization in a number of ways, including:

- Being a member of the Board of Directors and serving as Chair-Elect and Chair of the Environmental Nuclear Council in 2008-2009; as CRCPD Chairperson in 2009-2010; and as Past Chair in 2010-2012;
- Serving as member and Chair of the HS-5 Task Force for Development of the RDD Handbook;
- Serving as Chair of Environmental Nuclear Council's and Homeland Security Council's Emerging Issues Committee;
- Serving as Chair of the HS/ER-2 Committee for Expanding Radiation Preparedness in Public Health;
- Being instrumental in the formation of the National Alliance for Radiation Readiness and serving as one of the initial Tri-Chairs of the Alliance;
- Serving on the G-58 Task Force for the Criteria for an Adequate Radiation Control Program; and
- Chairing the E-43 Committee for Interagency environmental Data Sharing and Communication; and

Whereas: In recognition of her outstanding work with the CRCPD, Adela received several honors, including:

- Several Board of Directors Outstanding Achievement Awards for her contributions on several CRCPD working groups;
- A Board of Directors Meritorious Service Award for exemplary service on the Board of Directors in 2012; and
- The Gerald S. Parker Award, CRCPD's highest award, in 2014; and

Whereas: Adela's dedication and self-sacrifice to her chosen profession has earned her the right to a deserved and pleasant retirement.
