**Whereas:** In her support of the goals and objectives of the CRCPD, Kathleen has served the organization in a number of ways, including:

- Being a member of the Board of Directors and serving as Chair of the Suggested State Regulations Council from May 2003 to May 2006;

- Being a member of the Suggested State Regulations (SSR) - Group 1 (Parts C, T, M, O, P, S and U);
- Being a member of the HS-5 Task Force for Responding to a Radiological Dispersal Device;
- Being a member of the HS/ER-2 Committee for Expanding Radiological Emergency Preparedness in Public Health;
- Being an advisor to the HS/ER-4 Committee; and

**Whereas:** In recognition of her outstanding work with the CRCPD, Kathleen was awarded the Board of Directors Outstanding Achievement in the Field of Radiation Protection Award in 2001 for her work on E-23, in 2006 for her work on HS-5, and in 2009 for her work on HS/ER-2; and
