- Relating to:** Cynthia C. (Cindy) Cardwell's contributions to radiation protection and, in particular, her many significant contributions to the Conference of Radiation Control Program Directors, Inc. (CRCPD).
- Whereas:** Cindy Cardwell has given 33 years of professional service to the State of Texas in the Radiation Control Program of the Department of State Health Services and its predecessor agencies, where she served as incident investigator, standards specialist, Deputy Director for Standards, and Policy, Standards and Quality Assurance Radiation Group Manager.
- Whereas:** During her years with the State of Texas' radiation control program, Cindy has been a strong supporter of the CRCPD and an Associate Member since 1987; and
- Whereas:** In her support of the goals and objectives of the CRCPD, Cindy has served the organization in a number of ways, including:
- Being a member of the Board of Directors and serving as Chair of the Environmental Nuclear Council from May 1997 to May 2000; as Chair-Elect in 2001-2002; as CRCPD Chairperson in 2002-2003; and as Past Chair in 2003-2004;
 - Serving as a member and Chair of the G-34 Committee on Industrial Radiography (1990-1995), which was instrumental in the development of a national industrial radiography certification system;
 - Serving as Chair of the Suggested State Regulations Emerging Issues Committee;
 - serving as Chair of the SR-E Committee on Radiation Safety Requirements for Industrial Radiographic Operations;
 - Serving as a member of the SR-V Committee on Physical Protection of Byproduct Material;
 - Serving as a member and Chair of the G-58 Task Force for Criteria for an Adequate Radiation Control Program;
 - Serving as Chair for the G-57 Task Force for State Comprehensive Profile; and
 - Serving as a CRCPD representative on several NRC working groups.
- Whereas:** In recognition of her outstanding work with the CRCPD, Cindy has received several honors, including:
- Several Board of Directors Outstanding Achievement Awards for her contributions on several CRCPD working groups;
 - The James W. Miller Award in 1997 for the development and management of the industrial radiography certification program for the State of Texas; and
 - The Gerald S. Parker Award of Merit, CRCPD's highest award, in 2005.
- Whereas:** Cindy's dedication and self-sacrifice to her chosen profession, as well as being a lady and fashion standard-setter for CRCPD, have earned her the right to a deserved and pleasant retirement.


Now Therefore, Be It Resolved:
